SAFETY REGULATIONS AND GEAR

You must ALWAYS wear the following safety gear at the Skate Park/Mountain Bike facilities:

- 1. HELMET: Helps prevent injury to all areas of the head. Must be buckled and fit properly. Helmets models should be approved by a well-known organization (like Pro-Tec).
- 2. KNEEPADS: Used as the first point of dispersion for impact forces. During a fall, a skater should first drop to his or her knees. Kneepads must be worn at all times, and must be securely strapped around the leg to avoid coming off while skating and/or sliding.
- 3. ELBOW PADS: Give protection in backwards and sideways falls. Elbow pads must be worn at all times, and must be securely strapped around the arm to avoid coming off while skating and/or sliding.
- 4. WRIST PROTECTION: Skaters who lose their balance should try to fall forward. Wrist protection must be worn at all times, and be securely strapped around the hand and wrist to avoid coming off while skating and/or sliding.
- 5. All equipment should be hard plastic and designed to make you slide on a fall, rather than stopping short and becoming injured.
