System A: 24 ga. Steel 5-V-Crimp Metal Roof Panel –

HORIZONTAL LAPS ARE PERMITTED

Deck Type: Wood, Non-insulated

Deck Description: New Construction 19/32" or greater plywood or wood plank, or for re-roofing 15/32" or

greater plywood.

Maximum Uplift

Deck Attachment: In accordance with applicable Building Code, but in no case shall it be less than 8d ring

shank nails spaced 6" o.c. In reroofing, where the deck is less than ¹⁹/₃₂" thick (Minimum

 $\frac{15}{32}$ ") the above attachment method must be in addition to existing attachment.

Underlayment: Minimum underlayment shall be an ASTM D 226 Type II installed with a minimum 4" side-

lap and 6" end-laps. Underlayment shall be fastened with corrosion resistant tin-caps and 12 gauge 1 1/4" annular ring-shank nails, spaced 6" o.c. at all laps and two staggered rows 12"

o.c. in the field of the roll. Or, any approved underlayment having a current NOA.

Fire Barrier: Any approved fire barrier having a current NOA. Refer to a current fire directory listing for

fire ratings of this roofing system assembly as well as the location of the fire barrier within

the assembly. See Limitation # 1.

Valleys: Valley construction shall be in compliance with Roofing Application Standard RAS 133 and

with PAC Contractors Association's current published installation instructions.

Metal Panels and

Accessories:

Install the "24 ga. Steel 5-V-Crimp Metal Roof Panels" and accessories in compliance with PAC Contractors Association's current, published installation instructions and details. Flashing, penetrations, valley construction and other details shall be constructed in compliance with the minimum requirements provided in Roofing Application Standards RAS 133.

Panels shall be fastened with corrosion resistant #10 HWH screws of sufficient length to penetrate through the sheathing a minimum of $^{3}/_{16}$ ". Fasteners shall be installed parallel to the roof slope along the panel's overlapping ribs (fastening of the center rib is optional) at a

maximum spacing as listed in **Table A** below.

- 1. Fire classification is not part of this acceptance; refer to a current Approved Roofing Materials Directory for fire ratings of this product.
- 2. The maximum designed pressure listed herein shall be applicable to all roof pressure zones (i.e. field, perimeters, and corners). Neither rational analysis, nor extrapolation shall be permitted for enhanced fastening at enhanced pressure zones (i.e. perimeters, extended corners and corners).
- 3. Panel shall be roll formed in continuous lengths from eave to ridge. Maximum lengths shall be described in the Roofing Application Standard RAS 133. HORIZONTAL LAPS ARE PERMITTED
- **4.** All panels shall be permanently labeled with the manufacturer's name and/or logo, city and state of manufacturing facility, and the following statement: "Miami-Dade County Product Control Approved" **or** with the Miami-Dade County Product Control Seal as seen below. All clips shall be permanently labeled with the manufacturer's name and/or logo, and/or model.



- 5. All products listed herein shall have a quality assurance audit in accordance with the Florida Building Code and Rule 61G20-3 of the Florida Administrative Code.
- **6.** Panels may be shop or jobsite roll formed with machine model #**RF6632** from PAC Contractors Association.




