- Existing CROSSCO 5500 Acrylic Coatings: Apply two coats at a rate of 1 gal./80 ft<sup>2</sup> per coat to yield an average total thickness of 20 wet mils or 10 DFT.
- Concrete\*: Apply two coats at a rate of 1 gal./80 ft<sup>2</sup> per coat to yield an average total thickness of 20 wet mils or 10 DFT.

The product listed herein are components of roof assemblies and are approved for use with roof assemblies that list any of the products listed herein as part of their roof assemblies Notice of Acceptance. If a product is not listed as part of roof assemblies Notice of Acceptance, a request may be made to the local building official or the Miami Dade County Product Control Section for approval provided that appropriate documentation is provided.

- 9. The use of a reinforcing fabric in a maintenance coating is only to enhance the coating's ability to deliver efficient and long term performance through the protection of the underlying roof system and in this particular use does not become a roof system itself.
- **10.** All products listed herein shall have a quality assurance audit in accordance with the Florida Building Code and Rule 61G20-3 of the Florida Administrative Code.
- 11. All approved products listed herein shall be labeled in compliance with TAS 121 and shall bear the imprint or identifiable marking of the manufacturer's name or logo, city and state of manufacturing facility, and the following statement: "Miami-Dade County Product Control Approved" or the Miami-Dade County Product Control Seal as shown below.
