- 2. Field uplift testing shall be performed, in accordance with the test procedures set forth in Roofing Application Standard TAS 106. Testing shall be performed not prior to 30 days after installation.
- 3. QUIKRETE® 80# Roof Tile Mortar White 1140-83 shall be placed in a 5" x 12" pad at time of application. The mortar pad placement shall be in accordance with the 'Placement Details' provided herein. Each generic tile profile requires a specific placement, (see Placement Detail listed herein).
- **4.** QUIKRETE® 80# Roof Tile Mortar White 1140-83 shall be applied in accordance with The Quikrete Companies, LLC's specifications.
- 5. Tile must be applied within 5 minutes of the application of QUIKRETE® 80# Roof Tile Mortar White 1140-83.
- **6.** Refer to the tile manufacturer's Miami-Dade County Product Control Notice of Acceptance for system approvals.
- 7. All products listed herein shall have a quality assurance audit in accordance with the Florida Building Code and Rule 61G20-3 of the Florida Administrative Code.
- **8.** All bags shall be labeled and shall bear the imprint or identifiable marking of the manufacturer's name or logo, city and state of manufacturing facility, and following statement: "Miami-Dade County Product Control Approved" or the Miami-Dade County Product Control Seal as shown below.





PLACEMENT DETAIL "A"




PLACEMENT DETAIL "B"


