Application:

The FOAM-LOK LPA 2800-4G [R Formulation] polyurethane foam shall be applied uniformly over the entire surface of the insulation at the specified thickness in compliance with the requirements set forth in Roofing Application Standard RAS 109, But in no case shall it be less than 2". The sprayed polyurethane foam shall be feathered at the edges to

produce a smooth transition.

Protective Coating Application:

Apply THERMO-FLEX 1500HT Elastomeric Roof Coating or THERMO-SIL PRO 9600 High Solids Silicone Coating or another Miami-Dade County approved roof coating for use with SPUF with a current NOA applied in accordance with the guidelines

listed in the NOA.

Polyurethane foam surface shall be free of moisture, dust, debris, oils, tars, grease or other materials that will as recommended by Huntsman Building Solutions. impair adhesion of the protective coverings. Any damage or defects to the polyurethane foam surface shall be repaired prior to the coating application. The coating shall be applied the same day as the foam when possible. If more than 72 hours elapse prior to the application of the coatings,

the polyurethane foam shall be inspected for UV degradation.

Polyurethane Foam

Application:

The **FOAM-LOK LPA 2800-4G [S Formulation]** polyurethane foam shall be applied uniformly over the entire surface of the insulation at the specified thickness in compliance with the requirements set forth in Roofing Application Standard RAS 109, But in no case shall it be less than 2". The sprayed polyurethane foam shall be feathered at the edges to produce a smooth transition.

Protective Coating Application:

Apply THERMO-FLEX 1500HT Elastomeric Roof Coating or THERMO-SIL PRO 9600 High Solids Silicone Coating or another Miami-Dade County approved roof coating for use with SPUF with a current NOA applied in accordance with the guidelines listed in the NOA.

Polyurethane foam surface shall be free of moisture, dust, debris, oils, tars, grease or other materials that will as recommended by Huntsman Building Solutions. impair adhesion of the protective coverings. Any damage or defects to the polyurethane foam surface shall be repaired prior to the coating application. The coating shall be applied the same day as the foam when possible. If more than 72 hours elapse prior to the application of the coatings, the polyurethane foam shall be inspected for UV degradation.



GENERAL LIMITATIONS:

- Fire classification is not part of this acceptance, refer to a current Approved Roofing Materials Directory for fire ratings 1. of this product
- Spray polyurethane foam shall not be sprayed when ambient temperature is within 5 degrees of the dew point. Ambient 2. humidity applications limits shall be as listed in Table 1 herein. The contractor shall monitor and record environmental conditions in the Job Log in compliance with RAS 109. Job Log shall be maintained at the job site and accessible to The Building Official.
- Flashings and waterproof coverings for expansion joints shall be of compatible materials and in accordance with 3. Huntsman Building Solutions, published literature.
- 4. Miscellaneous materials such as adhesives, elastomeric caulking compounds, metal, vents and drains shall be a composite part of the roof system and shall be compatible with the foam and coating.
- All standard panel sizes are acceptable for mechanical attachment. When applied in approved asphalt, panel size shall 5. be 4' x 4' maximum.
- 6. Fastener spacing for insulation attachment is based on a Minimum Characteristic Force (F') value of 275 lbf., as tested in compliance with Testing Application Standard TAS 105. If the fastener value, as field-tested, are below 275 lbf. Insulation attachment shall not be acceptable.
- Perimeter and corner areas shall comply with the enhanced uplift pressure requirements of these areas. Fastener densities shall be increased for both insulation and base sheet as calculated in compliance with Roofing Application Standard RAS 117. Calculations prepared, signed and sealed by a Florida registered Professional Engineer, Registered Architect, or Registered Roof Consultant (When this limitation is specifically referred within this NOA, General Limitation #9 will not be applicable.)
- All attachment and sizing of perimeter nailers, metal profile, and/or flashing termination designs shall conform with 8. Roofing Application Standard RAS 111 and applicable wind load requirements.
- 9. The maximum designed pressure limitation listed shall be applicable to all roof pressure zones (i.e. field, perimeters, and corners). Neither rational analysis, nor extrapolation shall be permitted for enhanced fastening at enhanced pressure zones (i.e. perimeters, extended corners and corners). (When this limitation is specifically referred within this NOA, General Limitation #7 will not be applicable.)
