RESOLUTION RETROACTIVELY AUTHORIZING IN-KIND MIAMI-DADE PARK SERVICES FROM THE RECREATION DEPARTMENT, THE MIAMI DADE FIRE RESCUE DEPARTMENT, THE MIAMI-DADE ELECTIONS AND THE MIAMI-DADE POLICE DEPARTMENT NOVEMBER 17-18. DEPARTMENT FOR THE 2007 HARVEST FESTIVAL SPONSORED BY THE HISTORICAL ASSOCIATION OF SOUTHERN FLORIDA INC., A NOT-FOR-PROFIT ORGANIZATION, IN AN AMOUNT NOT TO EXCEED \$16.366.00 TO BE FUNDED IN PART FROM THE COUNTYWIDE IN-KIND RESERVE FUND, AND IN PART FROM THE NON-AD VALOREM PORTION OF THE FIRE RESCUE IN-KIND RESERVE FUND

WHEREAS, the Historical Association of Southern Florida, Inc. has requested in-kind services from the Miami-Dade Park and Recreation Department, the Miami-Dade Fire Rescue Department, the Miami-Dade Elections Department and Miami-Dade Police Department for the November 17-18, 2007 Harvest Festival in an amount not to exceed \$16,366.00 (see attached Fee Waiver/In-kind Service Application); and

WHEREAS, the purpose of the Harvest Festival is to promote educational programs, future exhibitions, and historical artifacts; and

WHEREAS, the Historical Association of Southern Florida, Inc. is a not-for-profit organization; and

WHEREAS, the Harvest Festival is a major event, as that term is defined on the attached Fee Waiver/In-kind Service Application, and \$14,526.00 of the in-kind services shall be funded from the Countywide In-kind Reserve Fund and \$1,840.00 of the in-kind services shall be funded from the non-ad valorem portion of the Fire Rescue In-kind Reserve Fund,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board retroactively authorizes in-kind services from the Miami-Dade Park and Recreation Department, the Miami-Dade Fire Rescue Department, the Miami-Dade Elections Department and Miami-Dade Police Department for the November 17-18, 2007 Harvest Festival in an amount not to exceed \$16,366.00 to be funded in part from the Countywide In-kind Reserve Fund and in part from the non-ad valorem portion of the Fire Rescue In-kind Reserve Fund.



The Office of Strategic Business Management (OSBM) has reviewed the attached in-kind request and recommends for the item to move forward to the Board of County Commissioners for consideration. The countywide in-kind reserve balance allows for the funding of this request.

Background

A retroactive waiver for in-kind services has been requested by a not-for-profit organization the Historical Association of Southern Florida, Inc. for the "Harvest Festival" held on November 17-18, 2007.

In-kind services have been requested in an amount not to exceed \$8,517 from the Miami-Dade Park and Recreation Department for the use of two small show mobiles, \$1,840 from the Miami-Dade Fire Rescue Department for personnel services, \$2,440 from the Miami-Dade Elections Department and \$3,569 from Miami-Dade Police Department for a total in-kind amount of \$16,366. This event will be funded in part from the countywide in-kind reserve fund and in part from the non-ad valorem in-kind reserve of the fire rescue district budget.

In FY 2007-08, the Historical Association of Southern Florida received \$180,066 from the Department of Cultural Affairs.
