RECOMMENDATION

The following plat meets concurrency and is hereby submitted for consideration by the Board of County Commissioners for approval. The Miami-Dade County Plat Committee recommends approval and recording of the plat listed below. This plat is bounded on the north by Bailes Road, on the east by approximately SW 114 Avenue, on the south by SW 232 Street, and on the west by approximately SW 117 Avenue.

BACKGROUND

BAILES SUBDIVISION (T-22682)

- Located in Section 18, Township 56 South, Range 40 East
- Commission District: 9
- Zoning: RU-1M(a)
- Proposed Usage: Single family residences
- Number of parcels: 11

PLAT RESTRICTIONS

- That the Street and Road, as shown on the plat, together with all existing and future planting, trees, shrubbery and fire hydrants thereon, are hereby dedicated to the perpetual use of the public for proper purposes, reserving to the dedicators, their successors or assigns, the reversion or reversions thereof whenever discontinued by law.
- That individual wells shall not be permitted within this subdivision, except for swimming pools, sprinkler systems and/or air conditioners.

- That the use of septic tanks will not be permitted within this subdivision, unless approved for temporary use, in accordance with County and State regulations.
- That all new electric and communication lines, except transmission lines, within this subdivision, shall be installed underground.
- That the utility easements, shown by dashed lines on the plat, are hereby reserved for the installation and maintenance of public utilities.
- Circular driveways will be required for lots fronting on SW 232 Street.

DEVELOPER'S OBLIGATION

- Milling, resurfacing, sidewalks, curb and gutter, valley gutter, striping and monumentation. Bonded under bond number 7760 in the amount of \$27,600.00.

RESOLUTION APPROVING THE PLAT OF BAILES SUBDIVISION, LOCATED IN THE SOUTHWEST 1/4 OF SECTION 18, TOWNSHIP 56 SOUTH, RANGE 40 EAST (BOUNDED ON THE NORTH BY BAILES ROAD, ON THE EAST BY APPROXIMATELY SW 114 AVENUE, ON THE SOUTH BY SW 232 STREET, AND ON THE WEST BY APPROXIMATELY SW 117 AVENUE)

WHEREAS, Jose C. Valladares, a married man, has this day presented to this Board a plat of certain lands lying in Miami-Dade County, Florida, said plat to be known as BAILES SUBDIVISION, the same being a subdivision of a portion of land lying and being in the Southwest 1/4 of Section 18, Township 56 South, Range 40 East, Miami-Dade County, Florida, and it appears that all requirements of law concerning said plat insofar as the authority of this Board is concerned have been complied with,

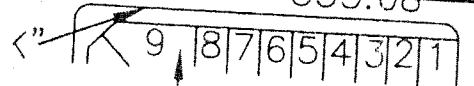
