Cortada has also worked with groups internationally to produce numerous art projects and installations, including environmental works in **Holland** (2009), **Quebec** (2009) and **Latvia** (2008), peace murals in **Cyprus** (2000) and **Northern Ireland** (2000), child welfare murals in **Bolivia** (1997) and **Panama** (1999), and the official International AIDS Conference murals in **Geneva** (1998) and **South Africa** (2000).

The Miami artist has also been commissioned to create art for the **White House** (2002), **the World Bank** (2003), **Miami City Hall** (2005), **Miami-Dade County Hall** (2004), **Miami Art Museum** (2001), **the Museum of Florida History** (2003) and **the Frost Art Museum** (2008).

Cortada, who was born in Albany, New York and grew up in Miami, holds degrees from the **University of Miami College of Arts and Sciences, Graduate School of Business and School of Law**. He currently serves as director of the Office of Engaged Teaching, Scholarship and Creative Activities at the **Florida International University College of Architecture + The Arts** in Miami, FL.

In **Florida**, he has worked with scientists, arborists and environmental managers to develop eco-art projects that engage community residents in bioremediation: coastal reforestation initiatives in **Miami** (Miami Science Museum, 2007), an urban reforestation campaign in **St. Petersburg** (Florida Botanical Gardens, 2009), and coral reef preservation efforts in **Hawaii** (Bishop Museum, 2010).

Cortada has also worked with groups internationally to produce numerous art projects and installations, including environmental works in **Holland** (2009), **Quebec** (2009) and **Latvia** (2008), peace murals in **Cyprus** (2000) and **Northern Ireland** (2000), child welfare murals in **Bolivia** (1997) and **Panama** (1999), and the official International AIDS Conference murals in **Geneva** (1998) and **South Africa** (2000).

The Miami artist has also been commissioned to create art for the **White House** (2002), the **World Bank** (2003), **Miami City Hall** (2005), **Miami-Dade County Hall** (2004), **Miami Art Museum** (2001), the **Museum of Florida History** (2003) and the **Frost Art Museum** (2008).

Corporations such as General Mills, Nike, Heineken and Hershey's have commissioned Cortada's art. Publishers like McDougal and Random House have featured it in school textbooks and publications. His work has also been featured in **National Geographic TV** and the **Discovery Channel**. ## **DR. HENRY LEWIS III**

### **Biographical Sketch**

Dr. Henry Lewis III is President of Florida Memorial University. He served as Dean and Professor in the College of Pharmacy and Pharmaceutical Sciences at Florida A&M University (FAMU) for the last 15 years. Dr. Lewis was Interim President of FAMU. He also served as Dean of the Texas Southern University College of Pharmacy and Health Sciences for four years.

A native of Tallahassee, Florida, he received his Bachelor of Science Degree in Pharmacy from FAMU and his Doctor of Pharmacy degree from Mercer University. He completed post-doctoral training in the Institute for Education Management at Harvard University, the National Institutes of Health, the Congressional Operations Institute, the American Association of State Colleges and Universities Millennium Presidential Leadership Program and Duke University Directors Program.

Dr. Lewis is past president of the Minority Health Professions Foundation. He is also past president of the Foundation's sister agency, the Association of Minority Health Professions Schools. Under his leadership, these two organizations—representing all of the nations historically black medical, dental, pharmaceutical, and veterinary medical programs—have secured over \$100 million in support of programs, research and activities that improve the quality of education and the availability of health care to minority and under-served communities. He has served as president of the National Pharmaceutical Association representing more than 10,000 minority pharmacists in the United States. He is the former Chairman of the Board of the Florida Education Fund, the nation's largest producer of African-American PhD's.

An accomplished biomedical researcher with a focus on sickle cell anemia, Dr. Lewis has been the principal investigator or project director on research/training grants totaling over \$95 million. He has served on numerous governmental review committees. The Secretary of HHS appointed him to currently serve on the National Center for Research Resources National Advisory Board. He has increased the endowment of the FAMU College of Pharmacy from \$1 million to over \$22 million under his leadership.

Dr. Lewis has testified before over a dozen Congressional subcommittees on health, research, and education funding issues. In 1986, he made history by becoming the first African American elected to the Leon County Board of County Commissioners in Tallahassee, Florida. While a Commissioner, he spearheaded the creation of the County's Minority Business Enterprise program, developed the branch health clinic network throughout the county, successfully advocated legislative funding for a \$2.5 million clinic building, and located the new \$20 million county public library downtown adjacent to the C.K. Steele bus terminal in the district he represented, making it accessible to all citizens of the city.

He has published over 25 scientific papers, book chapters and abstracts. He has received many awards and honors throughout his career. Among them are the FAMUAN of the Century, Outstanding Educator Award, Dr. Martin Luther King Leadership Award, Outstanding Tallahassee Award, Pharmacist of the Year, Teacher of the Year, Administrator of the Year and the National Faculty Researcher of the Year. Additionally, Eckerd Drugs (now CVS) funded the Henry Lewis III, Endowed Chair in his name, and the Richardson-Lewis Health Center in Tallahassee is named in his honor by the County Commission. Earlier this year, the National Pharmaceutical Association bestowed its highest recognition, the Wendell T. Hill Award upon him. He was re-elected to serve a second term on the Board of Directors of the Capital City Bank Group.

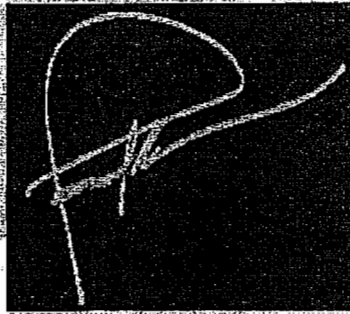

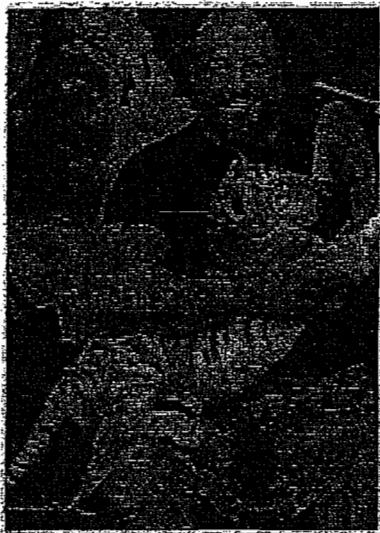

Mr. Tinnie serves a number of boards, including as Chair of the City of Miami Virginia Key Beach Park Trust, charged with the restoration and operation of Miami's fondly remembered one-time only "Colored Beach" during the segregation era, and he is often called upon to serve on grant review panels.
