#### MIAMPDADE CONTR ROADMAP CONTRACT NO. 9711-0/23 PIPE & FITTINGS FOR WATER & WASTEWATER SVC - PRE-QUAL

# I. The purpose of this contract is to provide a pool of pre-qualified vendors to source pipe and fittings for water and wastewater service on an as needed basis.

### II. Quotation Procedures:

The County will solicit spot market quotation from qualified bidders on an as-needed basis.

All pre-qualified bidders will be solicited for price and availability of projects as needed. All individual Request for Quotes should be reviewed for applicable measures prior to advertising. All quotations issued must be registered with SBD at the following link: <u>https://intra3.miamidade.gov/ISD/SBD/Login.aspx</u>. This link officially places your project on the Cone of Silence Report. Additionally the Office of the Commission Auditor (OCA) shall be copied at <u>oca@miamidade.gov</u> when quote is issued.

The Request for Quotation (RFQ) should include, at a minimum, language advising prequalified bidders that their bids should take account of all labor, supervision, material and equipment, permits, and any other items or incidentals. In addition, the RFQ should include any needed drawings, plans and will notify vendors, if applicable, of the following: pre-quotation conference or site visit, bid bond, performance security, liquidated damages, if the work is to be performed at night or on weekends, work completion deadline, method of award, the type of payment, time frames, the date for return of responses to the County of the RFQ, applicable Responsible Wages, Community Workforce Program (CWP), Logging/Videotaping of Well requirements, as well as any additional requirements.

#### III. Award Procedures:

All bidder(s) shall be notified of the award. The award date must be recorded so the cone of silence can officially be lifted. This step is accomplished by utilizing the same link used to originally post the quotations. The three (3) day protest period is applicable to all quotations.

#### *IV.* Applicable Ordinances for Quotations:

 Local Certified Service – Disabled Veteran should be applied in accordance with Section 2-8.5.1 of the Miami-Dade County Code, a Local Certified Service Disabled Veteran Business Enterprise (VBE) shall receive a bid preference of 5% of the price bid (for the purpose of evaluation ONLY). A VBE who is also an SBE shall not receive the veteran's preference and shall be limited to any applicable SBE preferences. At the time of bid submission, the

vendor must affirm in writing its compliance with the certification requirements of Section 295.187 of the Florida Status and submit this affirmation and a copy of the actual certification along with the bid.

Additionally, a Locally-Headquartered Business shall mean a Local Business as defined above which has a "principal place of business" in Miami-Dade County. "Principal place of business" means the *nerve center or the center of overall direction, control, and coordination of activities of the bidder*. If the bidder has only one business location, such business location shall be its principal place of business.

If the time for completion of an RFQ issued under this contract is greater than 30 days, it is subject to a CWP goal. As such, each RFQ greater than 30 days will be required to be presented to SBD for the application of a CWP goal.

6) Responsible Wages (Re: ITB Paragraph 2.24.3)

Miami-Dade County Code Section 2.11.16 will apply to any RFQ awarded pursuant to this Contract that exceeds \$100,000. The Contract User shall include a Responsible Wages and Benefits Schedule: Heavy Construction provision in any RFQ estimated to exceed \$100,000

V. How to Apply Bid and Local Preference to Quotes, if applicable:

1) Bid preferences shall be given to bidders that are identified as certified SBE/Micro, *if applicable*. The bid preference shall be calculated and subtracted from the total quote price or item for evaluation purposes only. The bid preference is used only to calculate an amount to be used in evaluating the quote and does not affect the final awarded price.

2) Whenever a quote contains both, Bid Preference (SBE/Micro) and Local Preference, departments must apply the bid preference first. Follow the Administrative Guidelines stated in the solicitation/contract document with regard to the applicable measure. The preference should be applied as listed in the table below based on the estimated value of the project and whether or not a set-aside or preference measure is applicable:
