I. <u>Purchasing Instructions</u>:

A. Award Description

Groups 1-5:

The purpose of this contract is to provide the printing of multi-part carbonless snap-out form services to various County departments. The County has awarded this contract to the single lowest-priced responsive and responsible vendor in the aggregate on a group-by-group basis for a **five**-year period, commencing February 1, 2020.

Group 6 (Pool):

Per Paragraph 2.4.2, Group 6 only – a Pool of Prequalified Vendors (Pool) is established under this contract to allow various County departments to obtain spot market quotes for additional items not already listed under the established groups. The Pool term shall run concurrent with the term of the awarded contract. However, subsequent spot market quotes may be issued for a specific duration.

- B. Quotation Directive:
 - Prequalified vendors will be invited to participate in spot market purchases for (Group 6 only) as required by the County for specific items not already awarded under the established groups. When spot market purchases are initiated, pre-qualified vendors shall be invited to offer a fixed price for a specific individual purchase/work order, or a specific purchasing period, based on the needs of each individual County department.
 - All quotations issued under this pre-qualification pool must utilize the current and active "terms and conditions" in place that includes the latest legislative changes. Please refer to the Internal Services Department Strategic Procuremement Division link (<u>http://www.miamidade.gov/procurement/itb-terms-conditions.asp</u>) to retrieve that latest version of the current T&Cs.
 - 3. All quotations issued should be reviewed by Small Business Development Division (SBD) for applicable measures prior to advertising.
- C. Price:

Prices Shall Be Fixed and Firm For 12 Months – Groups 1-5:

The prices proposed by the vendor under this contract shall remain fixed and frim for **one** year after the commencement of the contract. Thereafter, the County will consider yearly adjustments based on the Producer Price Index (PPI) Commercial Printing as published by the U.S. Department of Labor, Bureau of Labor Statistics, Washington, D.C.

D. Goods to be Provided – Groups 1-5:

Awarded bidder shall provide multi-part carbonless snap-out forms to include but not limited to holepunching, multi-color inks, numbering, padding, 2-sided printing and folding. The forms to be printed shall consist of the following:

- <u>Parts of Forms</u>: 2-Part, 3-Part, 4-Part, 5-Part and 6-Part
- 2. <u>Quantities of Forms (K=1,000 sets)</u>: 2.5K, 5K, 10K, 20K, 25K, 40K, 50K, 75K 100K and 200K
