For the purposes of scheduling a particular plat before the Commission, please note that the column labeled "Plat Submittal Deadlines (All Items)" refers to all items being received and <u>reviewed</u> by the Platting and Traffic Review Section; received and <u>reviewed</u> by all other governmental and private authorities needing to issue their concerns regarding the proposed development (i.e., Department of Transportation and Public Works (DTPW); Regulatory and Economic Resources (RER); Florida Department of Transportation (FDOT); Florida Power & Light, AT&T, etc., as applicable); and properly "<u>APPROVED</u>" <u>NO LATER</u> <u>THAN "NOON" OF THE DATE SHOWN</u> by the aforementioned entities before the plat will be scheduled before the Board of County Commissioners.

For the purposes of the "Opinion of Title Update (Last Item)", this date represents the deadline requirement for the submittal of this document to enable the scheduling of the plat to that particular agenda date. Failure to submit this updated opinion of title will result in the plat being removed from that agenda and tentatively rescheduled for the next available date, provided all other items are still within their respective approval time frames.

These deadlines were established to allow a minimum amount of time to properly review and approve all documentation submitted, and to meet the Agenda Coordinator's review, printing schedule, and public advertisement requirements.
