**Deck Type 1:** Wood, non-insulated

**Deck Description:** 19/32" or greater plywood or wood plank

**System E(1):** Anchor sheet mechanically fastened deck, membrane adhered.

Base Sheet: One or more plies of ASTM D 226 Type II or ASTM D 2626 with a minimum 4" side lap and a

6" end lap mechanically fastened to deck with approved nails and tin caps 6" o.c. at the laps and

two staggered rows 12" o.c. the field of the roll.

**Membrane:** One or more plies of WeatherLock G, WeatherLock MAT, AC Granular or Tri-Built Granular

with a minimum 3" side lap and 6" end lap. Place the first course of membrane parallel to the eave, rolling the membrane to obtain maximum contact. Remove the release membrane as the

membrane is applied.

**Roof Covering:** Approved for Asphaltic shingles, wood shakes and shingles, quarry slate roof assemblies.

Tile Roofing is not an approved roof covering for use with this assembly.

**Deck Type 1:** Wood, non-insulated

**Deck Description:** 19/32" or greater plywood or wood plank.

**System F(1):** Membrane self-adhered directly to deck.

Membrane: One ply of WeatherLock G, WeatherLock MAT, AC Granular or Tri-Built Granular with a

minimum 3" side lap and 6" end lap. Place the first course of membrane parallel to the eave, rolling the membrane to obtain maximum contact. Remove the release membrane as the

membrane is applied.

**Roof Covering:** Approved for Asphaltic shingles, wood shakes and shingles, quarry slate roof assemblies.

Tile Roofing is not an approved roof covering for use with this assembly.

#### **LIMITATIONS:**

- 1. Fire classification is not part of this acceptance.
- 2. This acceptance is for prepared roofing applications. Minimum deck requirements shall be in compliance with applicable building code. WeatherLock G, WeatherLock MAT, AC Granular or Tri-Built Granular underlayment shall be installed in strict compliance with applicable Building Code.
- 3. WeatherLock G, WeatherLock MAT, AC Granular or Tri-Built Granular underlayment shall be applied to a smooth, clean and dry surface with deck free of irregularities.
- 4. WeatherLock G, WeatherLock MAT, AC Granular or Tri-Built Granular underlayment shall not be applied over an existing roof membrane as a recover, but may be applied over a roofing Base/Anchor sheet underlayment.
- 5. WeatherLock G, WeatherLock MAT, AC Granular or Tri-Built Granular underlayment shall not be left exposed as a temporary roof for longer than 30 days of application.
- 6. Refer to Prepared Roofing System Product Control Notice of Acceptance for listed approval of this product with specific prepared roofing products.
- 7. WeatherLock G, WeatherLock MAT, AC Granular or Tri-Built Granular underlayment may be used with any approved roof covering Notice of Acceptance listing WeatherLock G, WeatherLock MAT, AC Granular or Tri-Built Granular underlayment as a component part of an assembly in the Notice of Acceptance. If WeatherLock G, WeatherLock MAT, AC Granular or Tri-Built Granular underlayment is not listed, a request may be made to the Authority Having Jurisdiction (AHJ) or the Miami-Dade County Product Control Department for approval provided that appropriate documentation is provided to detail compatibility of the products, wind uplift resistance, and fire testing results.
- 8. All nails in the deck shall be carefully checked for protruding heads. Re-fasten any loose decking panels. Sweep the deck thoroughly to remove any dust and debris prior to application.
- 9. When applying the membrane in the valley, start at the low point and work to the high point, rolling the membrane from the center outward in both directions. For ridge applications, center the membrane and roll from the center outward in both directions.
- 10. Roll or broom the entire membrane surface so as to have 100% contact with the surface, giving special attention to overlap areas.
- 11. Flash vent pipes, stacks, chimneys and penetrations in compliance with Roof Assembly Current Product Control Notice of Acceptance and applicable Building Code.
- 12. All protrusions or drains shall be initially taped with a 6" piece of underlayment. The flashing tape shall be pressed in place and formed around the protrusion to ensure a tight fit. A second layer of WeatherLock G, WeatherLock MAT, AC Granular or Tri-Built Granular underlayment shall be applied over the underlayment.
- 13. All products listed herein shall have a quality assurance audit in accordance with the Florida Building Code and Rule 61G20-3 of the Florida Administrative Code.
- 14. All membranes or packaging shall bear the imprint or identifiable marking of the manufacturer's name or logo and the following statement: "Miami-Dade County Product Control Approved" or the Miami-Dade County Product Control Seal as shown below.
