o.c. in the field of the roll. Or any approved underlayment having a current NOA.

Valleys: Valley construction shall be in compliance with Roofing Application Standard RAS 133 and

with Blac Investments, Inc. dba Tri County Metals current published installation instructions.

Metal Panels and

Accessories:

Install the "PBR 26 Gauge Metal Panel" and accessories in compliance with Blac Investments, Inc. dba Tri County Metal's current, published installation instructions and details. Flashing, penetrations, valley construction and other details shall be constructed in compliance with the minimum requirements provided in Roofing Application Standards RAS 133.

Panels shall be fastened with corrosion resistant #12 HWH screws with self-sealing washers of sufficient length to penetrate through the sheathing a minimum of $^{3}/_{16}$ ". Fasteners shall be installed parallel to the roof slope in a 5"-7"-5"-7" pattern across the panel as shown in the Detail Drawings herein. The row of fasteners shall be spaced at a maximum spacing as listed in Table A below.

- 2. The maximum designed pressure listed herein shall be applicable to all roof pressure zones (i.e., field, perimeters, and corners). Neither rational analysis, nor extrapolation shall be permitted for enhanced fastening at enhanced pressure zones (i.e., perimeters, extended corners and corners).
- **3.** Panel shall be roll formed in continuous lengths from eave to ridge. Maximum lengths shall be described in the Roofing Application Standard RAS 133.
- 4. All panels shall be permanently labeled with the manufacturer's name and/or logo, city and state of manufacturing facility, and the following statement: "Miami-Dade County Product Control Approved" or with the Miami-Dade County Product Control Seal as seen below. All clips shall be permanently labeled with the manufacturer's name and/or logo, and/or model.






