

NOVEMBER 2024 HIGHLIGHTS




- 1. Total employment in Miami-Dade County (M-DC) showed a year-over-year increase of 0.1% to nearly 1.364 million in November 2024, while Florida decreased 0.8% to nearly 10.639 million, and the U.S. decreased 0.5% to 161.141 million.
- 2. M-DC had the lowest unemployment rate of 2.4% compared to Florida's 3.4%, and the U.S. at 4.2%.
- 3. The unemployment rates rose in all these areas over the last month, with M-DC seeing the largest increase of 70 basis points (BPs) from 1.7% the prior year. Florida increased 30 basis BPs from 3.1%, and the U.S. increased 50 basis BPs from 3.7%. (100 BPs = 1%)
- 4. In M-DC, nine of the twelve sectors grew year over year. The top three fastest growing sectors include construction, up 10.5% to new record high levels, other services were up 3.9%, leisure and hospitality was up 3.3%, and wholesale trade was up 2.6%. Among the major employment sectors, four of the twelve sectors in M-DC grew faster than the state, with construction outpacing Florida by 6%, professional and business services by 1.6%, leisure and hospitality by 0.8%, and education and health services by 0.2%.
- 5. Average weekly earnings in M-DC lagged the U.S. by 12%. Employees in the County, on average, made below those in the nation, by \$146.21 per week. Earnings in M-DC rose 5.7% year over year to \$1,075.21, while the U.S. increased 3.7% to \$1,221.42.
- 6. Average weekly hours for all employees in M-DC increased 2.6% year over year to 35.9 hours, while in the U.S., they fell 0.3% to 34.3 hours. On average, employees in M-DC worked an additional 1.6 hours per week compared to those in the nation.
- 7. In terms of labor force status, for the population between 16 and 25 years in M-DC, more than one half were not in the labor force for 'Other' reasons, e.g. school or college. Over the prior year, M-DC saw an increment of 1.2% to 60.6% in 'Other', Broward also increased 10.5% to 47.8%, while Palm Beach decreased 12.8% to 33.8%. The share of employed workers in M-DC in this age group decreased 3.4% to 35.7%, Broward decreased 7.7% to 48.1%, while employed-workers in Palm Beach increased 10.2% to 60%.
- 8. More than four-fifths of workers in M-DC between age 26 and 65 years were in the labor force, 80.8%, of which employed workers increased 0.1% from 2023, to 78.8% in 2024. In Broward, there were 82.9% in the labor force and employed workers decreased 1% to 80.5%. In Palm Beach, 76.3% were in the labor force and those who were employed increased 0.6% to 74.1%.
- 9. For those over 65 years, three-fourths of the population were not in the labor force, primarily in 'Other', which includes retirees. With this, the share in 'Other' fell 7.7% over the prior year to 75.7% in M-DC, Broward increased 1.8% to 77.8%, and Palm Beach 0.2% to 79.9%.
- 10. On average for 'All Ages' in M-DC, 63.5% were in the labor force, of which employed workers increased 0.7% to 61.6%. In Broward, 65.9% were in the labor force and those who were employed decreased 2.3% to 63.7% over the same period. Meanwhile in Palm Beach, 57.9% were in the labor force, and the share of employed workers also increased, up 0.5% to 55.7%.






Employment, Unemployment Rate, and Unemployed











Employment-Sectors, Wages and Hours











Labor Force Status by Age Group

(All rates are the average for a trailing 12-month period ending November of each year)









(Rates are the average for a trailing 12-month period ending November of each year)





Definitions:

Employed: Employed workers in this category include individuals who receive a wage or salary, profit or fees, or payment in kind (such as housing, meals, or supplies received in place of cash wages), and worked at least 1 hour as a paid employee or at least 1 hour in their own business, or farm, whether they were paid for the time off. It also includes individuals who were temporarily absent from their job, business, or farm, whether they were paid for the time off, and individuals who worked without pay for a minimum of 15 hours in a business or farm owned by a member of their family. Each employed person is counted only once in aggregate employment, even if they hold more than one job.

The following individuals were not included, volunteer work, unpaid internships, unpaid programs, training programs, training programs not sponsored by an employer, even if receiving public assistance payment for attending, National Guard or Reserve duty(weekend or summer training), ownership in a business or farm solely for investment purposes, with no participation in its management or operation, jury duty, work around one's home such as cleaning, painting, repairing, or other housework or home improvement project.

Unemployed: Unemployed individuals in this group include those who were not employed during the survey reference week, individuals who were available for work during the survey reference week, except for temporary illness, and those with at least one specific active effort to find a job during the 4-week period ending with the survey reference week or they were temporarily laid off and expecting to be recalled to their job.

Discouraged: Discouraged includes those who searched for a job in the last 12 months but not in the last 4 weeks, believing no job is available.

Other: Others not in the labor force include those who do not want a job or haven't searched for a job in over a year, or are not available for work.
