## Chairman's Message



Over the course of the year, we have made great progress in advancing several of our rapid transit corridor projects – particularly the Northeast and South corridors.

Early this year, the South Florida Regional Transportation

Authority (SFRTA) began offering service to and from MiamiCentral Station in Downtown Miami, marking the beginning of Tri-Rail commuter service along the Northeast Corridor. The Citizens' Independent Transportation Trust (CITT) played a crucial role in its development and continues to work with its transportation partners to fully develop this corridor.

The Northeast Corridor – one of six rapid transit corridors in the Strategic Miami Area Rapid Transit (SMART) Program and the original People's Transportation Plan (PTP) – is poised to receive more than \$263 million in funding as part of the federal FY 24-25 budget.

We are also seeing the advancement of the South Corridor, with stations along the South Dade TransitWay scheduled to reach completion in early 2025, and with the construction of a South Dade Transit Operations Center that will support the all new battery-electric buses that will operate along the South Corridor – all funded by Surtax dollars.

Many residents have attended our Full Trust meetings, and written to us, to voice their support for the North Corridor. In May, the CITT echoed their support by passing a Resolution that urges Miami-Dade County, the Florida Department of Transportation and its partners to take all necessary actions to accelerate the implementation of elevated heavy rail transit along the North Corridor.

The CITT continues to increase its community engagement efforts with its CITT Ambassador Program, Mobility Matters podcast, and a series of PTP presentations to municipalities and local organizations. #### Tri-Rail Arrives at MiamiCentral Station

After several years of planning, early this year, the South Florida Regional Transportation Authority (SFRTA), which runs Tri-Rail, arrived at MiamiCentral Station, providing commuter service to and from Downtown Miami.

From the beginning, the Citizens' Independent Transportation Trust (CITT) played a crucial role in its development – first by working with the necessary agencies to bring the project to reality, and later allocating nearly \$14 million in Surtax funds for the project. It also closely monitored its progress to ensure delivery of the project.



"This new service will provide not only an affordable alternative to driving to Downtown Miami, but it will also create opportunities for

economic growth via the rise of Transit Oriented Communics like the ones we now



see surrounding the MiamiCentral Station," said CITT Chair Robert Wolfarth.

The MiamiCentral Station is also an important and critical component of the Northeast Corridor, which is one of six rapid transit corridors in the Strategic Miami Area Rapid Transit (SMART) Program and the original People's Transportation Plan (PTP).

# Miami-Dade County Breaks Ground on the Dadeland South Intermodal Station

In the spring of 2024, the Miami-Dade Department of Transportation and Public Works broke ground on the Dadeland South Intermodal Station. This project will expand the current Dadeland South Metrorail Station, providing a better facility for transit riders and those who bike or walk to the station.

As part of the upgrades, the new intermodal station will offer many benefits that include:



- A seamless connection and reduced transfer time from Bus Rapid Transit (BRT) service on the South Corridor on to our Metrorail system
- New canopies to better protect transit riders from weather elements
- Easier and safer access in the drop-off and pick-up area
- Bicycle amenities and an at-grade bike path connecting The Underline and the South Dade Trail (adjacent to the TransitWay).



In support of this project, the CITT voted in favor of allocating \$81 million in Surtax dollars to fund the construction of improvements that are part of the Dadeland South Intermodal Station.

"This project will greatly enhance the riding experience, as it will offer a seamless connection between multiple transit modes and first/last-mile solutions via connections to bicycle and pedestrian trails," said CITT Chair Robert Wolfarth.

#### **Municipalities and Community Organizations Receive CITT** and PTP Updates



This summer, the CITT kicked off a series of presentations to increase awareness of Surtax-funded projects and engage more with our community.

"It's important for our local residents to see what is being done with their Surtax dollars," said CITT Chair Robert Wolfarth. "This is one of the many ways in which we are reaching out to our community to let them know of the work that is being done with their halfpenny, and to learn from our residents what they see as transportation priorities in their community."

#### Miami-Dade County Begins Construction of a New Transit Operations Center Photo Credit: DTPW

This summer, the Miami-Dade County Department of Transportation and Public Works began construction of the South Dade Transit Operations Center.

Located near the Homestead Air Reserve Base, this modern transit facility will house and maintain a new fleet of 100 zero-emissions 60-foot



articulated battery-electric buses. The buses will provide service along the new South TransitWay stations, currently under construction. Both the buses and facility are being funded with Surtax dollars.

"This new facility, funded by the People's Transportation Plan Surtax dollars, will play a crucial role in better serving the transit needs of south Miami-Dade - one of the fastest-growing areas of our county. It will help our county government to better meet the increasing demand for reliable and efficient public transportation, connecting more people to jobs, education, and essential services," said CITT Chair Robert Wolfarth.

The project is scheduled to be completed in Summer 2026 with portions opening as soon as Summer 2025.
