



**REGIONAL MEMORANDUM OF UNDERSTANDING BETWEEN
MIAMI-DADE COUNTY, FLORIDA (UNITED STATES OF AMERICA) AND
THE COMMUNITY OF MADRID (KINGDOM OF SPAIN)**

The Parties hereto, Miami-Dade County, Florida, United States of America, (the "County") and the Community of Madrid, Kingdom of Spain ("Madrid") (collectively, the Parties), wish to carry out a Regional Memorandum of Understanding as more specifically described below:

1. CONSIDERING that it is economically and culturally beneficial for regions around the world to establish affiliations with each other; and

2. CONSIDERING that business and commercial exchanges are a paramount component of the Regional Understanding programs, and given that they help create connections between officials, institutions and international companies that foster trust, access and experience, and help local companies to find new opportunities and resources, including access to new markets, assistance in dealing with import and export regulations, and the introduction of new business partners; and

3. CONSIDERING that another vital component of the relations between the Regions is the exchange of art and culture and, in 2015, the Parties carried out a declaration of cooperation in which they expressed their mutual desire to strengthen the cultural and artistic exchange between them, develop the potential of artistic associations between museums, art centers, theaters, performing arts companies and special events in their communities, and explore the possibilities of exchange of artists for presentations and residencies in both communities, amongst other things; and

4. CONSIDERING that the Parties share an important business relationship with each other; and

5. CONSIDERING that Madrid, the home region of the capital of the Kingdom of Spain and one of the most populous regions in Europe, is home to more than 2,000 multinational companies and 72 per cent of the 2,000 largest Spanish companies; and

6. CONSIDERING that the economies of both Parties are largely based on trade and tourism, and the Parties wish to further expand industrial and commercial bonds, tourism, health, agriculture, arts and educational opportunities;

NOW, THEREFORE, BE IT RESOLVED BY MIAMI DADE COUNTY, FLORIDA (UNITED STATES OF AMERICA) AND THE COMMUNITY OF MADRID (KINGDOM OF SPAIN), THAT THE UNDERSIGNED PARTIES AGREE TO:

1. Establish a Regional Memorandum of Understanding with each other.

2. Explore programs, arrangements, activities, transactions, agreements and other ways to improve trade and business opportunities for the citizens of both Parties, mutually benefit the development and economic growth and tourism of both Parties and increase the prosperity of the citizens of both Parties.



3. Explore ways to increase cultural, artistic and educational exchanges between the Parties.
4. Participate in a program for the exchange of good practices to improve the economic and social well being of the citizens of each Party.
5. Carry out business, commercial, artistic and cultural development missions in each community.
6. Make frequent reports and recommendations to their respective governing bodies regarding the abovementioned objectives.

This Memorandum is not legally binding and is not subject to International Law.

RESOLUTION DIRECTING THE COUNTY'S INTERNATIONAL TRADE CONSORTIUM TO NEGOTIATE AND, TO THE EXTENT FEASIBLE, PREPARE A REGIONAL MEMORANDUM OF UNDERSTANDING WITH THE COMMUNITY OF MADRID, SPAIN, FOR EXECUTION BY THE COUNTY MAYOR OR COUNTY MAYOR'S DESIGNEE; AND DIRECTING THE INTERNATIONAL TRADE CONSORTIUM TO MONITOR PERFORMANCE OF SUCH MEMORANDUM OF UNDERSTANDING AND PROVIDE A REPORT TO THIS BOARD IF NEGOTIATION AND EXECUTION IS UNSUCCESSFUL

WHEREAS, it is economically and culturally beneficial to establish affiliations between Miami-Dade County, Florida (the "County") and other cities throughout the world; and

WHEREAS, business and trade exchanges between different cities help create connections between international municipal officials, institutions, and businesses that build trust, access, and expertise and help local businesses find new opportunities and resources, including access to new markets, assistance navigating import and export regulations, and introductions to new business partners; and

WHEREAS, the County is the Gateway to the Americas; and

WHEREAS, Spain is a crucial trade partner to the County, and more than 500 Spanish companies are doing business in South Florida; and

WHEREAS, PortMiami has sister seaport agreements in place with 14 Spanish ports; and

WHEREAS, in 2021, the total value of trade between Spain and South Florida exceeded \$800,000,000.00; and

WHEREAS, the Community of Madrid, in particular, is vital not only because it is the seat of Madrid, the capital of Spain, but also because (1) it is home to more than 2,000 multinational companies; (2) four percent of Latin America's GDP is managed by Madrid companies; (3) 72 percent of the largest 2,000 Spanish companies are based in Madrid; and (4) Madrid is one of the most populous cities in Europe; and

WHEREAS, another vital component of relationships between cities is the exchange of arts and culture, and the County, in 2015, jointly signed a cooperation declaration with Madrid wherein the County expressed its desire to strengthen the cultural and artistic exchange between both communities, develop the potential of artistic partnerships between museums, art centers, theaters, performing arts companies and special events in both communities, and explore the possibilities of exchanging artists for presentations and residencies in both communities, among other things; and

WHEREAS, the County has established relationships with numerous cities in South America, Central America, the Caribbean, Europe, Africa, and Asia; and

WHEREAS, under section 2-1501 of the Code of Miami-Dade County (the "Code"), the Jay Malina International Trade Consortium of Miami-Dade County (the "ITC"), an advisory board to this Board, is charged with, among other things, cultivating trade opportunities both locally and abroad; and

WHEREAS, chambers of commerce play a vital role in developing trade opportunities and promoting economic development; and

WHEREAS, the Latin Chamber of Commerce of U.S.A. (CAMACOL), in partnership with its sister organization, CAMACOL Doral, plays a vital role in promoting economic development in the County; and

WHEREAS, through the work of chambers of commerce like CAMACOL and the trade missions and other entrepreneurial initiatives that they make possible, the County recognizes the importance of relationships with other cities and, in particular, the importance of a relationship with the Community of Madrid, Spain; and

WHEREAS, as a result of the great benefits in trade, tourism, cooperation, and understanding brought by relationships between different cities, this Board would like to direct the ITC to negotiate and, to the extent feasible, prepare a regional memorandum of understanding with the Community of Madrid, Spain, for execution by the County Mayor or County Mayor's designee,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board:

Section 1. Directs the ITC to negotiate and, to the extent feasible, prepare a regional memorandum of understanding with the Community of Madrid, Spain, in substantially the form of the regional memorandum of understanding attached hereto (the "MOU"), and transmit such MOU to the County Mayor or County Mayor's designee for execution.

Section 2. Authorizes and directs the County Mayor or County Mayor's designee to execute such MOU upon receipt from the ITC.

Section 3. Directs the ITC to monitor the performance of such executed MOU in connection with its powers and duties under sections 2-1501 through 2-1503 of the Code.

Section 4. Directs the ITC to provide a report to this Board within 60 days of the effective date of this resolution if negotiation and execution of the MOU is unsuccessful and to place the completed report on an agenda of the full Board without committee review pursuant to Ordinance No. 14-65.

The Prime Sponsor of the foregoing resolution is Chairman Jose "Pepe" Diaz. It was offered by Commissioner _____, who moved its adoption. The motion was seconded by Commissioner _____ and upon being put to a vote, the vote was as follows:

The signatories hereto, Miami-Dade County, Florida, United States of America, (the "County") and the Community of Madrid, Kingdom of Spain ("Madrid") (collectively, the signatories), wish to enter a Regional Memorandum of Understanding as described below more specifically:

1. WHEREAS, it is economically and culturally beneficial for regions around the world to establish affiliations with each other; and
2. WHEREAS, business and trade exchanges are a critical component of Regional Understanding programs, and help create connections between international officials, institutions, and businesses that foster trust, access, and expertise, and help local businesses find new opportunities and resources, including access to new markets, assistance in dealing with import and export regulations, and introductions to new business partners; and
3. WHEREAS, another vital component of relations between the regions is the exchange of arts and culture and, the Signatories implemented a Declaration of Cooperation in 2015 expressing their mutual desire to strengthen cultural and artistic exchange, develop the potential for artistic partnerships between museums, art centers, theaters, performing arts companies, and special events in their communities, and explore the possibilities of artist exchanges for performances and residencies in both communities, inter alia; and
4. WHEREAS, the Signatories share a significant business relationship; and
5. WHEREAS, Madrid, the home region of the capital of the Kingdom of Spain and one of the most populous regions in Europe, is home to more than 2,000 multinational companies and 72 percent of the 2,000 largest Spanish companies; and
6. WHEREAS, the economies of both Signatories are largely based on trade and tourism, and the Signatories desire to further expand industrial and trade links, tourism, health, agriculture, arts and educational opportunities.

NOW, THEREFORE, BE IT RESOLVED BY MIAMI-DADE COUNTY, FLORIDA (UNITED STATES OF AMERICA) AND THE COMMUNITY OF MADRID (KINGDOM OF SPAIN), THAT THE SIGNATORIES HEREBY AGREE TO:

1. Establish a Regional Memorandum of Understanding with each other.
2. Explore programs, arrangements, activities, transactions, agreements and other ways to enhance trade and business opportunities for the citizens of both Signatories, seek mutually beneficial economic development and growth and tourism opportunities for both Signatories, and increase the prosperity of the citizens of both Signatories.
3. Explore ways to increase cultural, artistic and educational exchanges between the Signatories.
4. Participate in a best-practice exchange program to improve the economic and social well-being of the citizens of each Signatory.
5. Conduct business, commercial, artistic and cultural development missions in each community.
6. To make periodic reports and recommendations to their respective governing bodies in relation to the above goals.
