

RESOLUTION NO. R-775-94

RESOLUTION ESTABLISHING SISTER CITY PROGRAM
BETWEEN METROPOLITAN DADE COUNTY AND
DEPARTAMENTO SANTA CRUZ, BOLIVIA

WHEREAS, representatives of Metropolitan Dade County and Departamento Santa Cruz, Bolivia met and expressed a desire to establish a Sister City Program between the two governments and their people; and

WHEREAS, this Board desires to accomplish the purposes outlined in this resolution,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF DADE COUNTY, FLORIDA, that:

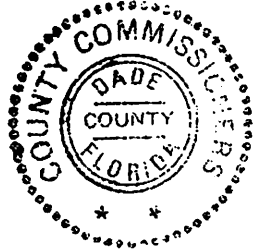
Section 1. This Board, on behalf of the citizens of Metropolitan Dade County, Florida, hereby establishes a Sister City Program with the government and citizens of Departamento Santa Cruz, Bolivia.

Section 2. A committee shall be appointed to establish the Sister City Program and carryout the objectives of fostering enhanced economic and social relations between the two governments and their people.
