
The Mayor of Pucallpa, the Honorable Melita Ruiz de Padilla, and the City Council of Pucallpa passed on June 23, 1995 Ordinance # 017-95 approving of this relationship. Please see attached copy of resolution.

The City of Pucallpa meets the guidelines established by the Board of County Commissioners on April 4, 1995 for the establishment of new Sister Cities. Pucallpa has a large river port which is the only major transhipment point from the interior of Peru to the nations capital of Lima and the Pacific Ocean. This river port handles most of the cargo trade between the western frontier of Brazil and Peru.
