RESOLUTION NO. R-1098-95

RESOLUTION ESTABLISHING SISTER CITY PROGRAM
BETWEEN DADE COUNTY AND STOCKHOLM COUNTY,
SWEDEN

WHEREAS, representatives of Metropolitan Dade County and Stockholm County, Sweden, met and have expressed a desire to establish a Sister City Program between the two governments and their people; and

WHEREAS, this Board wishes to establish a sister city program between Dade County and Stockholm County, Sweden,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF DADE COUNTY, FLORIDA, that:

Section 1. This Board on behalf of the citizens of Metropolitan Dade County, Florida, hereby establishes a Sister City Program with the government and citizens of Stockholm County, Sweden.

Section 2. A committee shall be appointed to establish the Sister City Program and carry out the objectives of fostering enhanced economic and social relations between the two governments and their people.

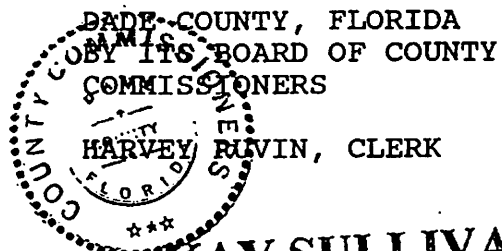
