Elected Membership shall be composed of one (1) man and one (1) woman for every 1000 registered Democrats, or fraction thereof, residing in the DEC election district as of January 1st in the year of a Presidential election and who shall be elected from each of the DEC election districts at the first Primary election in a Presidential election year.
