Subject: Resolution approving the Waiver of Plat of RADDA VAZQUEZ ZALDIVAR AND ERNESTO ZALDIVAR, JR.

Recommendation

The following waiver of plat is hereby submitted for consideration by the Board of County Commissioners for approval. This plat is bounded on the north approximately 300 feet south of SW 326 Street, on the east approximately 500 feet west of theoretical SW 198 Avenue, on the south by SW 328 Street, and on the west approximately 1280 feet east of SW 202 Avenue. The Miami-Dade County Plat Committee, comprised of representatives from the Florida Department of Transportation, the Florida Department of Health, the Miami-Dade County School Board and Miami-Dade County departments of Fire Rescue, Parks, Recreation and Open Spaces, Regulatory and Economic Resources (RER), Public Works and Waste Management (PWWM), and Water and Sewer, recommends approval of this waiver of plat.

Scope

This waiver of plat is located within the boundaries of Commission District 9, Commissioner Dennis C. Moss.

Fiscal Impact/Funding Source

There is no associated fiscal impact to Miami-Dade County with the approval of this waiver of plat; all improvements are in place.

RESOLUTION APPROVING THE WAIVER OF PLAT OF RADDA VAZQUEZ ZALDIVAR AND ERNESTO ZALDIVAR, JR, LOCATED IN THE SOUTHEAST 1/4 OF SECTION 15, TOWNSHIP 57 SOUTH, RANGE 38 EAST (BOUNDED ON THE NORTH APPROXIMATELY 300 FEET SOUTH OF SW 326 STREET, ON THE EAST APPROXIMATELY 500 FEET WEST OF THEORETICAL SW 198 AVENUE, ON THE SOUTH BY SW 328 STREET, AND ON THE WEST APPROXIMATELY 1280 FEET EAST OF SW 202 AVENUE).

WHEREAS, Radda Vazquez Zaldivar and Ernesto Zaldivar, Jr., husband and wife, have this day presented to this Board a waiver of plat of certain lands lying in Miami-Dade County, Florida, said waiver of plat of the property legally described as a portion of land lying and being in the Southeast 1/4 of Section 15, Township 57 South, Range 38 East, Miami-Dade County, Florida, and it appears that all requirements of law concerning said waiver of plat insofar as the authority of this Board is concerned have been complied with,
