Resolution approving the Plat of CORAL TERRACE COMMERCIAL CENTER

Recommendation

The following plat is hereby submitted for consideration by the Board of County Commissioners for approval. This plat is bounded on the north by SW 24 Street, on the east SW 70 Court, on the south approximately 300 feet north of SW 26 Street, and on the west by SW 71 Avenue. The Miami-Dade County Plat Committee, comprised of representatives from the Florida Department of Transportation, the Florida Department of Health, the Miami-Dade County School Board and Miami-Dade County Departments of Fire Rescue, Parks, Recreation and Open Spaces, Regulatory and Economic Resources (RER), Public Works and Waste Management (PWWM), and Water and Sewer, recommends approval and recording of this plat.

Scope

This plat is located within the boundaries of Commission District 6, Chairwoman Rebeca Sosa.

Fiscal Impact/Funding Source

The fiscal impact to the County would be approximately \$500.00 per year for the annual maintenance of new road construction along Coral Way, SW 70 Court, and SW 71 Avenue, once the new portions of these roads are constructed adjacent to the project, which will be funded through PWWM General Fund allocation.

Track Record/Monitor

RER, Development Services Division administers the processing of plats and waivers of plat, and the person responsible for this function is Raul A. Pino, P. L. S.

Plat Restrictions

- That SW 24th Street (Coral Way), SW 71st Avenue, and SW 70th Court, as illustrated on the plat, together with all existing and future planting, trees, shrubbery and fire hydrants thereon, are hereby dedicated to the perpetual use of the public for proper purposes, reserving to the dedicators, their successors and assigns the reversion or reversions thereof, whenever discontinued by law.
- That the use of septic tanks will not be permitted on any tract within this subdivision, unless approved for temporary use, in accordance with County and State regulations.
- That all new electric and communication lines, except transmission lines, within this subdivision, shall be installed underground.
- That the utility easements at the front and side of the Tract, depicted by dashed lines on the plat, are hereby reserved for the installation and maintenance of public utilities.

• Improvements adjacent to this project bonded under the bond for the plat of Coral Terrace Center, Bond Number 7890.

RESOLUTION APPROVING THE PLAT OF CORAL TERRACE COMMERCIAL CENTER, LOCATED IN THE NORTHEAST 1/4 OF SECTION 14, TOWNSHIP 54 SOUTH, RANGE 40 EAST (BOUNDED ON THE NORTH BY SW 24 STREET, ON THE EAST BY SW 70 COURT, ON THE SOUTH APPROXIMATELY 300 FEET NORTH OF SW 26 STREET, AND ON THE WEST BY SW 71 AVENUE)

WHEREAS, Pan American Coral Terrace, Ltd., a Florida limited partnership, has this day presented to this Board a plat of certain lands lying in Miami-Dade County, Florida, said plat to be known as CORAL TERRACE COMMERCIAL CENTER, the same being a replat of Tract "B" and a portion of Tract "A" of "Davidson Lumber Co. Subdivision", according to the plat thereof, as recorded in Plat Book 117, at Page 1, of the Public Records of Miami-Dade County, Florida, lying and being in the Northeast 1/4 of Section 14, Township 54 South, Range 40 East, Miami-Dade County, Florida, and it appears that all requirements of law concerning said plat insofar as the authority of this Board is concerned have been complied with,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that said plat is hereby approved; that the dedication of the streets, alleys and other rights-of-way however designated or depicted on said plat is hereby accepted; that the Miami-Dade County Plat Restrictions as listed on said plat are approved and are to be enforced; that approval of the plat is not a waiver of any zoning regulations and that the requirements of the zoning existing on this land at the time this Resolution is approved shall be enforced whether or not the various parcels on this plat conform


