Resolution approving the Plat of CORAL TERRACE INDUSTRIAL

Recommendation

The following plat is hereby submitted for consideration by the Board of County Commissioners for approval. This plat is bounded on the north approximately 675 feet south of SW 26 Street, on the east by SW 69 Court, on the south by SW 29 Road, and on the west approximately 280 feet east of SW 71 Avenue. The Miami-Dade County Plat Committee, comprised of representatives from the Florida Department of Transportation, the Florida Department of Health, the Miami-Dade County School Board and Miami-Dade County Departments of Fire Rescue, Parks, Recreation and Open Spaces, Regulatory and Economic Resources (RER), Public Works and Waste Management (PWWM), and Water and Sewer, recommends approval and recording of this plat.

Scope

This plat is located within the boundaries of Commission District 6, Chairwoman Rebeca Sosa.

Fiscal Impact/Funding Source

The fiscal impact to the County would be approximately \$450.00 per year for the annual maintenance of new road construction along SW 69 Court and SW 29 Road, once the new portions of these roads are constructed adjacent to the project, which will be funded through PWWM General Fund allocation.

Track Record/Monitor

RER, Development Services Division administers the processing of plats and waivers of plat, and the person responsible for this function is Raul A. Pino, P. L. S.

- That SW 69th Court and SW 29th Road, as illustrated on the plat, together with all existing and future planting, trees, shrubbery and fire hydrants thereon, are hereby dedicated to the perpetual use of the public for proper purposes, reserving to the dedicators, their successors and assigns the reversion or reversions thereof, whenever discontinued by law.
- That the use of septic tanks will not be permitted on any tract within this subdivision, unless approved for temporary use, in accordance with County and State regulations.
- That all new electric and communication lines, except transmission lines, within this subdivision, shall be installed underground.
- That the utility easements at the front and sides of the Tract, depicted by dashed lines on the plat, are hereby reserved for the installation and maintenance of public utilities.

Improvements adjacent to this project bonded under the bond for the plat of Coral Terrace Center, Bond Number 7890.
