RESOLUTION NAMING BASEBALL **FACILITY** HAMMOCKS COMMUNITY PARK, LOCATED AT 9885 "AL HAMMOCKS BOULEVARD, AS THE **ENGLE** COMPLEX"; **DIRECTING** THE BASEBALL COUNTY MAYOR OR MAYOR'S DESIGNEE TO COORDINATE WITH THE DISTRICT 11 COMMISSIONER TO INSTALL APPROPRIATE **SIGNAGE** INDICATING **SUCH** USING DISTRICT DESIGNATION 11 **QUALITY** NEIGHBORHOODS IMPROVEMENT PROGRAM (QNIP) **FUNDS** 

WHEREAS, Albert ("Al") Engle was born in Brooklyn, New York on January 23, 1936; and

WHEREAS, Al loved the game of baseball from the time he was a small boy, playing stick ball in the streets, going to watch the Brooklyn Dodgers play at Ebbets Field in the Flatbush section of Brooklyn, and playing baseball all through his high school years; and

WHEREAS, after his time in the Navy, Al worked in Washington, D.C. before being transferred to Miami in 1963; and

WHEREAS, Al raised his kids to love baseball and coached his sons at Flagami,
Tamiami and Hammocks parks; and

WHEREAS, although Al worked long hours as the Chief Executive Officer of a local company, he always found time to be involved at Hammocks Community Park; and

**WHEREAS**, after working closely with Al Rose in 1992, Al Engle became President of the Kendall Hammocks Optimist baseball program in 1997; and

WHEREAS, after his term ended, Al Engle took over as the President of Baseball Operations and remained in that capacity until December 2013; and

WHEREAS, January 2014 marks the 27th anniversary of Kendall Hammocks Optimist bringing baseball to the youth community at Hammocks Community Park and Devonaire Park; and

WHEREAS, Al Engle's true love was making children smile and watching them grow as they learned and enjoyed the game of baseball at Hammocks Community Park; and

WHEREAS, Al felt that all children who wanted to play baseball should be able to regardless of their financial circumstances, and each season he would pay the registration fees for several children out of his own pocket; and

WHEREAS, even in retirement, Al worked tirelessly in service of the youth community at Hammocks Community Park, and his final thoughts before passing away were of things that still needed to be done at the park; and

WHEREAS, by naming the baseball facility at Hammocks Community Park as the "Al Engle Baseball Complex," this Board desires to make a lasting recognition of Al Engle's legacy as a selfless servant to the Miami-Dade County community and mentor and friend to the thousands of baseball players that have played at Hammocks Community Park,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board:

Section 1. Having considered this matter at a public hearing, desires to honor Al Engle's legacy by naming the baseball facility at Hammocks Community Park, located at 9885 Hammocks Boulevard, as the "Al Engle Baseball Complex."

Section 2. Directs the County Mayor or Mayor's designee to coordinate and work with the Commissioner of District 11 to install an appropriate marker to indicate this designation using District 11 Quality Neighborhoods Improvement Program (QNIP) funds.

Section 3. Directs the Clerk of the Board to transmit a certified copy of this resolution to Al Engle's next of kin.
