Ordinance No. 13-29, adopted on April 2, 2013, requires the Office of the Commission Auditor (OCA) to complete background research on any person, organization, place or thing that is the subject of a naming, renaming or codesignation item.

In accordance with the Ordinance, we are providing this report as a supplement to the Board of County Commissioners (BCC) Agenda Item 5(D). Pursuant to Ordinance No. 13-29, the OCA completed background research regarding BCC Agenda Item 5(D), and the following information was found pursuant to the Miami-Dade County Clerk of Courts public records search.
