RESOLUTION CODESIGNATING SW 110th AVENUE FROM SW 32nd SUBJECT:

STREET TO SW 40th STREET AS "EUCARIO BERMUDEZ WAY" BY A

THREE-FIFTHS VOTE OF BOARD MEMBERS PRESENT

Ordinance No. 13-29, adopted on April 2, 2013, requires the Office of the Commission Auditor (OCA) to complete background research on any person, organization, place or thing that is the subject of a naming, renaming or codesignation item.

In accordance with the Ordinance, we are providing this report as a supplement to the Board of County Commissioners (BCC) Agenda Item 5(C). Pursuant to Ordinance No. 13-29, the OCA completed background research regarding BCC Agenda Item 5(C). The following information was found pursuant to the Miami-Dade County Clerk of Courts public records:

- April 16, 1986- Case No. 85-3260 CA-10; Final Summary Judgment Against Eucario Bermudez in the amount of \$175,627.77.
 - o June 26, 1992- Case No. 85-3260 CA-10; Satisfaction of Judgment- Payment and full satisfaction in exchange for \$30,000.00.
- November 18, 1991- Notice of Filing- Petition under Chapter 7 of the U.S. Bankruptcy Code was filed on November 5, 1991 in the U.S. Bankruptcy Court for the Southern District of Florida, Miami Division, by Eucario Bermudez and Luz Elena Bermudez.
