RESOLUTION HONORING LEGENDARY MUSICIAN AND
SONGWRITER JIMMY BUFFETT AND EXPRESSING
SYMPATHY AND CONDOLENCES UPON HIS PASSING

WHEREAS, on September 1, 2023, Florida resident and legendary musician Jimmy Buffett passed away after battling cancer; and

WHEREAS, with a recording career that spanned more than fifty years and included hits such as “Margaritaville,” “Cheeseburger in Paradise,” and “It’s Five O’Clock Somewhere,” Mr. Buffett was one of the world’s most successful performers in popular music; and

WHEREAS, an inductee of the Florida Artists Hall of Fame, Mr. Buffett captured the Florida lifestyle and entertained generations of Floridians with his relaxed “Floridays” style that embodied the spirit of South Florida, the Gulf Coast, and the Conch Republic; and

WHEREAS, Mr. Buffett’s song “Margaritaville” led to successes on and off the stage, becoming a namesake for his business ventures, which include restaurants, resorts, and a lifestyle brand; and

WHEREAS, a lifelong conservationist, Mr. Buffett founded the Save the Manatee Club in 1981, and he demonstrated his appreciation for the Florida Everglades through philanthropic efforts and song; and

WHEREAS, this Board wishes to honor the life and legacy of Jimmy Buffett through this expression of sympathy,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board honors Jimmy Buffett, a celebrated musician who epitomized the South Florida lifestyle, and expresses its sympathy and condolences to his family upon his passing.
