### **SUMMARY**

This item seeks the approval of the Board of County Commissioners to award the construction project of Miami-Dade Fire Rescue Crandon Park Ocean Rescue Headquarters to Home Express Corporation d/b/a HE Builders. The Miami-Dade Fire Rescue Department (MDFR) will be constructing a new, 7,000 square foot, single story, Ocean Rescue Headquarters facility at Crandon Park located inside the North Beach Parking lot. In addition to administrative offices, this facility will include public restrooms, meeting rooms and storage for equipment. This ocean rescue permanent facility will provide ocean rescue service to the Crandon Beach area located within District 7. The total compensation amount is \$7,168,593.35, with a total contract term of 450 calendar days (approximately 1 year and 3 months). This contract was competitively bid on (7 bid packages issued; 4 bids received).

#### **RECOMMENDATION:**

It is recommended that the Board of County Commissioners (Board) approve the attached resolution awarding construction Project No. 2022-MDFR-CR-OR-HQ, Miami-Dade Fire Rescue Crandon Park Ocean Rescue Headquarters to Home Express Corporation d/b/a/ HE Builders. The total compensation amount is \$7,168,593.35. This recommendation to Award has been prepared by the Miami-Dade Fire Rescue Department.

**BACKGROUND:** The Miami-Dade County Board of County Commissioners approved the reconstruction of the Ocean Rescue Facility via Resolution No. R-928-14. At a meeting on June 23, 2016, the Crandon Park Amendment Committee (CPAC) members reviewed the proposed site plan and floor plan documents provided to them, and after discussion, approved the reconstruction of the Ocean Rescue Facility with a total building footprint of 7,210 square feet. MDFR has been working with Park and Recreation Open Spaces since the inception of this project and received a concurrency letter prior to the permitting application/process (permit application was signed by Park and Recreation Open Spaces). Additionally, MDFR's Design and Construction staff has been working in conjunction with Park and Recreation Open Spaces and their assigned Construction Manager Liaison to ensure compliance with the Crandon Park Amendment Committee's approval for design and construction.

Miami-Dade County Fire Rescue Department, Crandon Park Ocean Rescue Facility will be a one-story CBS structure with a total building footprint of approximately 7,000 square feet. Once constructed the building facility will reside on Crandon Park North Beach, Key Biscayne, Florida, and will accommodate Miami-Dade Fire Rescue life safety and Ocean Rescue support staff for the protection of our constituents, community, and beaches. The building design includes an Educational Lobby; Officer Offices; Safety Support Dispatch; Training Room; Lounge Room; Exercise Room; Men & Women Locker Rooms; Vehicles and Equipment Garage; and Public Bathrooms for beach visitors. The facility will be designed and constructed to meet the LEED Silver Certification for Green Buildings, and Park & Recreation Open Spaces guidelines.


