RESOLUTION NO.

RESOLUTION URGING PRESIDENT JOSEPH R. BIDEN, JR. AND SECRETARY OF STATE ANTONY J. BLINKEN TO TAKE AFFIRMATIVE MEASURES TO DISSUADE KENYA FROM FURTHER MILITARY INVOLVEMENT IN HAITI AND PREVENT ANY OTHER FOREIGN INVOLVEMENT IN HAITI

WHEREAS, hundreds of thousands of residents of the County are either Haitian immigrants or of Haitian ancestry; and

WHEREAS, many of those residents have family members that still reside in Haiti; and

WHEREAS, in recent years, Haiti has been plagued by a violent gang war primarily fought

in the nation's capital, Port-au-Prince; and

WHEREAS, as a result, on October 2, 2023, the United Nations Security Council adopted

United Nations Security Council Resolution 2699, which authorized the "Multinational Security

Support Mission in Haiti" (hereinafter, the "U.N. Mission"); and

WHEREAS, to the concern of many Haitians, County residents, and this Board, the U.N.

Mission will involve the intervention of an armed multinational force in Haiti; and

WHEREAS, in the interim, the threat to Haiti's national security caused by criminal gangs has devolved into a humanitarian crisis in recent months; and

WHEREAS, despite recent escalation of the crisis in Haiti, this Board is concerned about further foreign intervention in Haiti, especially given the poor track record of such efforts; and

WHEREAS, indeed, foreign intervention has likely resulted in great harm to the Haitian people, and has probably worsened the nation's instability in the last few decades; and

WHEREAS, the hundreds of millions of dollars being spent on the U.N. Mission would be better spent on training the Haitian police and military; and

WHEREAS, several noteworthy publications have covered this issue and published pieces arguing against foreign intervention in Haiti; and

WHEREAS, for example, the Miami Herald published an opinion piece by Charnette Frederic and Marleine Bastien, available at https://www.miamiherald.com/opinion/op-ed/article281594743.html, asserting the United States should cease its unconditional support of the current Haitian government and allow pro-democratic movements in Haiti to flourish; and

WHEREAS, the Miami Herald published an opinion piece by Mario Joseph and Brian Concannon, available at <u>https://www.miamiherald.com/opinion/op-ed/article266022281.html</u>, asserting that armed intervention by foreign powers is unhelpful and that such a measure would be an expensive, brutal failure; and

WHEREAS, the New York Times published an opinion piece by Pierre Espérance, available at <u>https://www.nytimes.com/2023/10/04/opinion/haiti-police-gangs.html</u>, making similar assertions as the above-mentioned articles; and

WHEREAS, certain advocacy groups have likewise called for the cessation of foreign intervention in Haiti; and

WHEREAS, the National Haitian American Elected Officials Network ("NHAEON"), comprised of about 82 current elected officials from the District of Columbia and 17 States throughout the U.S., has written an open letter to President Joseph R. Biden, Jr. and Secretary of State Antony J. Blinken to strongly oppose the current administration's position in support of the international military intervention in Haiti; and

WHEREAS, this Board believes that ending Haiti's crises will ultimately require ending foreign interference in Haitian affairs, which is often what generated the crises in the first place or exacerbated such crises; and

WHEREAS, Haitians have demonstrated a history of coming together to make their way out of a crisis; and

WHEREAS, in no way should this resolution be construed as urging armed intervention by the United States; and

WHEREAS, this Board wishes to ensure that the crisis in Haiti ceases, and that residents of Haiti can live in peace and a state of security,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board:

Section 1. Urges President Joseph R. Biden, Jr. and Secretary of State Antony J. Blinken to take affirmative measures to dissuade Kenya from further military involvement in Haiti and prevent any other foreign involvement in Haiti.

Section 2. Directs the Clerk of the Board to transmit a certified copy of this resolution to President Joseph R. Biden, Jr. and Secretary of State Antony J. Blinken.

Section 3. Directs the County's federal and lobbyists to advocate for the action described in section 1 above, and authorizes and directs the Office of Intergovernmental Affairs to amend the 2024 Federal Legislative Package to include this item.

The Prime Sponsor of the foregoing resolution is Commissioner Marleine Bastien. It was offered by Commissioner , who moved its adoption. The motion was seconded by Commissioner and upon being put to a vote, the vote was as follows:
