RESOLUTION APPROVING THE CITY OF MIAMI GARDENS' CODESIGNATION OF THAT PORTION OF NORTHWEST 17TH AVENUE FROM NORTHWEST 183RD STREET TO NORTHWEST 188TH STREET AS "ALPHA KAPPA ALPHA WAY" AND CODESIGNATION OF THAT PORTION OF NORTHWEST 42ND AVENUE FROM NORTHWEST 157TH STREET TO NORTHWEST 162ND STREET AS "ALPHA PHI ALPHA WAY"; AND CODESIGNATING THAT PORTION OF NORTHWEST 32ND AVENUE FROM NORTHWEST 191ST STREET TO NORTHWEST 199TH STREET AS "KAPPA ALPHA PSI WAY"

WHEREAS, the City Council of the City of Miami Gardens (the "City") passed a resolution, which is attached hereto and incorporated by reference, on May 22, 2024, which codesignated that portion of Northwest 17th Avenue from Northwest 183rd Street to Northwest 188th Street as "Alpha Kappa Alpha Way" to honor Alpha Kappa Alpha Sorority, Inc. ("Alpha Kappa Alpha"); and

WHEREAS, founded in 1908, Alpha Kappa Alpha has been at the forefront of efforts to address the community needs, including those of the City, by empowering families, building economic wealth, and advocating for social justice; and

WHEREAS, that portion of Northwest 17th Avenue from Northwest 183rd Street to Northwest 188th Street is a city road located in the City within County Commission District 1; and

WHEREAS, this Board would also like to honor Alpha Kappa Alpha by approving the City's codesignation of that portion of Northwest 17th Avenue from Northwest 183rd Street to Northwest 188th Street as "Alpha Kappa Alpha Way"; and

WHEREAS, the City passed a resolution, which is attached hereto and incorporated by reference, on July 24, 2024, which codesignated that portion of Northwest 42nd Avenue from Northwest 157th Street to Northwest 162nd Street as "Alpha Phi Alpha Way" to honor Alpha Phi Alpha Fraternity, Inc. ("Alpha Phi Alpha"); and

**WHEREAS**, Alpha Phi Alpha is the first intercollegiate Greek-lettered fraternity established for African American men and was founded in 1906 at Cornell University; and

WHEREAS, the Alpha Phi Alpha Beta Beta Lambda chapter, which was chartered in Miami, Florida in 1937, has been a pillar in the Greater Miami community with a focus on educational, economic, political, and social programs and initiatives; and

WHEREAS, that portion of Northwest 42nd Avenue from Northwest 157th Street to Northwest 162nd Street is a city road located in the City within County Commission District 1; and

**WHEREAS**, this Board would also like to honor Alpha Phi Alpha by approving the City's codesignation of that portion of Northwest 42nd Avenue from Northwest 157th Street to Northwest 162nd Street as "Alpha Phi Alpha Way"; and

WHEREAS, the City passed a resolution, which is attached hereto and incorporated by reference, on September 11, 2024, authorizing the codesignation of that portion of Northwest 32nd Avenue from Northwest 191st Street to Northwest 199th Street as "Kappa Alpha Psi Way" to honor Kappa Alpha Psi Fraternity, Inc. ("Kappa Alpha Psi"); and

WHEREAS, Kappa Alpha Psi is a collegiate historically Black Greek-lettered organization founded in 1911 at Indiana University; and

WHEREAS, local chapters of Kappa Alpha Psi participate in community outreach activities to feed the homeless, provide scholarships to young people matriculating to college, serve as mentors to young men, participate in blood drives, and serve as hosts of seminars for public health awareness; and

WHEREAS, that portion of Northwest 32nd Avenue from Northwest 191st Street to Northwest 199th Street is a county-maintained road located in the City within County Commission District 1; and

WHEREAS, Rule 9.02 of the Board's Rules of Procedure provides that resolutions regarding proposed naming, renaming, or codesignation of Miami-Dade County roads, facilities, or property shall be sponsored by the district commissioner where the road, facility, or property is located and shall be considered at a public hearing; and

WHEREAS, the City would like for the County to install signage indicating these codesignations on County street signs and traffic signal mast arms; and

WHEREAS, this Board would also like to honor Kappa Alpha Psi by codesignating that portion of Northwest 32nd Avenue from Northwest 191st Street to Northwest 199th Street as "Kappa Alpha Psi Way",

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board:

Section 1. Approves the City of Miami Gardens' codesignation of that portion of Northwest 17th Avenue from Northwest 183rd Street to Northwest 188th Street as "Alpha Kappa Alpha Way" and codesignation of that portion of Northwest 42nd Avenue from Northwest 157th Street to Northwest 162nd Street as "Alpha Phi Alpha Way".

Alpha Kappa Alpha Sorority, Incorporated was founded January 15, 1908 on the campus of Howard University. As the first Greek-lettered organization established by African American college-educated women, Alpha Kappa Alpha has blazed trails and shattered ceilings, paving the way for future generations of women leaders. The impact of Alpha Kappa Alpha extends far beyond its membership, inspiring individuals of all backgrounds to strive for excellence and be of "Service to All Mankind."

Since its inception, Alpha Kappa Alpha has been instrumental in shaping the fabric of community's worldwide. Service, sisterhood, and scholarship has always been the cornerstone of the organization. The organizations unwavering commitment to social justice and advocacy has left a lasting impact on Miami-Dade County, with members leading the charge for education, voting rights, affordable housing, and equality.

The lovely ladies of Alpha Kappa Alpha Sorority, Inc. are dedicated to providing impactful and meaningful service to the residents of the City of Miami Gardens that extend beyond its service initiatives, as the sorority has been a steadfast advocate for social change and civic engagement. Through its advocacy efforts, members of Alpha Kappa Alpha have worked tirelessly to address systemic inequalities, advocate for policy reform, and empower individuals to participate in the democratic process. WHEREAS, through its initiatives, Alpha Kappa Alpha has addressed the unique needs of the community including the residents of the City of Miami Gardens. From empowering families, building economic wealth, enhancing the environment and advocating for social justice to uplifting the community, the sorority's dedication to service has translated into many tangible benefits for residents, and

WHEREAS, Section 34-233 of the City of Miami Gardens Code of Ordinance outlines the process for renaming and co-designating streets, and

WHEREAS, Section 44-233(b)(10) provides guidance for the Mayor and members of the City Council to sponsor a Resolution for the renaming or co designation of a street, and

Since its founding on December 4, 1906<sup>TM</sup> at Cornell University in Ithaca, New York, Alpha Phi Alpha Fraternity, Inc. has supplied voice and vision to the struggle of African Americans and people of color around the world.

The Beta Beta Lambda chapter was chartered in Miami, Florida on Friday, November 19th, 1937 and has been a pillar in the Greater Miami community with a focus on improving the community through educational, economic, political, and social programs and initiatives. For its effort during the last seven decades, Beta Beta Lambda Chapter has been honored four times [1975, 1985, 1986, & 2006] as Alpha Phi Alpha Fraternity's National Alumni Chapter of the Year and remains a consistent winner of the Florida Federation of Alpha Chapter's District Chapter of the Year Award for more than 25 years.

Section 34-233 of the City of Miami Gardens Code of Ordinance outlines the process for renaming and co-designating streets. In addition, section 44-233(b)(10) provides guidance for the Mayor and members of the City Council to sponsor a Resolution for the renaming or co-designation of a street.

Councilman Leon aims to commemorate Alpha Phi Alpha's mission to develop leaders, promote brotherhood and academic excellence, while providing service and advocacy for our communities. Heseeks to honor the Fraternity's rich history and strong legacy by officially recognizing and dedicating NW 42nd Avenue, between NW 157th Street and NW 162nd Street, as "Alpha Phi Alpha" Way. Councilman Reggie Leon requests support for this item as he deems it befitting to celebrate all fraternities and sororities of the National Pan-Hellenic Council (NPHC), commonly known as the Divine Nine, who have served our community for over 50 years by way of streets named in their honor.

#### **Staff Summary**

Kappa Alpha Psi Fraternity, Incorporated is the second oldest existing collegiate historically Black Greek letter fraternity and the only Greek letter organization founded with the concept of achievement in every field of human endeavor established on January 5, 1911, on the campus of Indiana University, in Bloomington Indiana. The worldwide prominence of Kappa Alpha Psi and the quest for social justice and civil rights during the twentieth century has had global impact on events that affect our local communities as well as the world. Members of Kappa Alpha Psi have served as key figures in the Civil Rights Movement, the fight against apartheid, and the fight against childhood catastrophic diseases.

Kappa Alpha Psi has proven to be concerned for youth through their unwavering commitment and allegiance to mentorship, while enhancing the civic, educational, social and overall well-being of the communities and organizations it serves, including the residents of the City of Miami Gardens.

Section 34-233 of the City of Miami Gardens Code of Ordinance outlines the process for renaming and co-designating streets. In addition, section 44-233(b)(10) provides guidance for the Mayor and members of the City Council to sponsor a Resolution for the renaming or co-designation of a street.

As a lasting tribute to the fraternity's contributions and accomplishments, while also highlighting its commitment to uplifting and empowering families of the Miami Gardens community, Councilman Leon seeks to celebrate the fraternity by formally recognizing and dedicating NW 32nd Avenue between NW 191st Street to NW 199th Street, as "Kappa Alpha Psi Way."
