Subject: Recommendation for Approval of a Designated Purchase under Contract No. RFP-

01385, Seaweed Removal and Mechanical Beach Cleaning

#### **Recommendation**

It is recommended that the Board of County Commissioners authorize this request for a designated purchase under *Contract No. RFP-01385*, *Seaweed Removal and Mechanical Beach Cleaning*, for the Parks, Recreation and Open Spaces Department. The additional expenditure authority is needed to expand services in Miami Beach from 26 Street south to 22 Street on a more frequent basis. Tides, current, and locations where seaweed is deposited are challenging to predict. The Department did not anticipate that the Beach Renourishment Project would contribute to this being a continual hot spot when requesting the award or previous modification under delegated authority.

Approval of the designated purchase is being requested, pursuant to Section 2-8.1(b)(3) of the Miami-Dade County Code, by a two-thirds vote of the Board members present, to authorize additional expenditure authority in the total amount of \$4,295,000, consisting of \$665,000 for the first option to renew term, \$1,186,080 for the second option to renew term, \$1,209,780 for the third option to renew term, and \$1,233,960 for the fourth option to renew term to expand seaweed removal and beach cleaning services on Miami Beach.

The Board awarded this competitively established contract on April 7, 2020, through Resolution No. R-301-20 for a one-year term with four, one-year options to renew. The contract was subsequently modified under delegated authority.

The County currently provides mechanical beach cleaning, seaweed collection, removal, and disposal services at the following beaches: Government Cut Jetty North; Miami Beach break waters from approximately 26 Street to 32 Street; and Bal Harbour at Haulover Cut Jetty North (Haulover Park) and Haulover Cut Jetty South. The U.S. Army Corp of Engineers completed a Beach Renourishment Project that included areas in Miami Beach between 24 Street and 26 Street which unexpectedly shifted seaweed accumulation to this area. This additional seaweed accumulation resulted in several public inquiries as to why the other portions of the beach were being mitigated with more frequency. The portion of the beach that is regularly affected was not included in the original solicitation since it was only being affected on a seasonal basis.

Competition is not practicable at this time as the timely removal of seaweed is paramount andhaving potentially multiple vendors provide services on the same strip of land could lead to inconsistencies in the process of seaweed removal and beach cleaning services resulting in varied appearance for beachgoers. Accordingly, it is in the County's best interest to approve this designated purchase pursuant to Section 2-8.1(b)(3) of the County Code to continue to purchase seaweed removal and beach cleaning services. Pursuant to Resolution No. R-391-17, while competition is not feasible, the contract contains all current Board mandated terms.

#### **Scope**

Bal Harbour, Haulover Park and Miami Beach are located in Commission Districts 4 and 5, which are represented by Commissioner Sally A. Heyman and Commissioner Eileen Higgins.

#### **Delegated Authority**

The County Mayor or the County Mayor's designee will have the authority to exercise all provisions of the contract, including any renewals, cancellation or extensions, pursuant to Section 2-8.1 of the County Code and Implementing Order 3-38.

#### **Fiscal Impact/Funding Source**

The current option to renew term expires on April 30, 2022. The contract has a current cumulative allocation of \$5,840,000. The three one-year options to renew remaining were approved by the Board for \$8,692,380 through Resolution No. R-301-20; therefore, the existing cumulative value of the contract is \$14,532,380. If this request is approved, the contract will have a modified cumulative allocation of \$18,827,380. The requested increase in expenditure authority is based on anticipated usage throughout the remainder of contract.
