Recommendation

It is recommended that the Board of County Commissioners (Board) authorize the County Mayor or County Mayor's designee to exercise the three one-year renewal terms with Nan McKay and Associates, Inc. under *Contract No. RFP-01132, Section 8 Housing Voucher Services* (the "Contract"), for the Public Housing and Community Development Department (PHCD).

The Board approved this competitively solicited contract on November 19, 2019, via Resolution No. R-1221-19 for a two-year initial term. Pursuant to Resolution No. R-1221-19, the County Mayor or County Mayor's designee was required to seek approval of the Board prior to exercising the three, one-year options to renew terms contained in the Contract. The Contract's initial term expires on December 31, 2021.

Approval of the three one-year options to renew is requested to ensure continuity of services. The Contract provides for the administration and management of the Section 8 Housing Choice Voucher Program (Program). This federal Program offers subsidies to families, veterans, the elderly and the disabled as well as providing affordable, safe and sanitary housing in the private market. Services under the Program comprise intake, case management, family self-sufficiency and inspections. The awarded vendor manages and operates the Program waiting list, provides intake and new admission services and conducts on-going tenant services.

Scope

The scope of this item is countywide in nature.

Fiscal Impact/Funding Source

The Contract term expires on December 31, 2021 and has a current allocation of \$24,155,764. If this request is approved, the Contract will have a cumulative allocation of \$51,614,410 and will expire on December 31, 2024. There is no fiscal impact to the general fund as this contract is federally funded.
