**Subject:** Resolution Approving the Plat of Siena North Filed by OCS-HS Lot Option Pool 01,

L.P.

# Recommendation

The following plat is submitted for consideration by the Board of County Commissioners (Board) for approval. This plat for Siena North is bounded on the North approximately 95 feet south of SW 209 Lane, on the east by SW 127 Avenue, on the south by SW 216 Street, and on the west approximately 135 feet east of SW 128 Court.

The Miami-Dade County Plat Committee recommends approval of this plat. The Plat Committee is comprised of representatives from:

- Florida Department of Transportation;
- Florida Department of Health;
- Miami-Dade County School Board; and
- Miami-Dade County Departments of Fire Rescue; Parks, Recreation and Open Spaces; Regulatory and Economic Resources; Transportation and Public Works; and Water and Sewer.

Pursuant to Ordinance No. 16-73, this quasi-judicial matter may be submitted directly for placement on the Board's meeting agenda by the Director of the Department of Regulatory and Economic Resources.

A location sketch is attached to this memorandum as Exhibit A.

Full scale copy of the plat and legal description of the boundaries of the land being subdivided, as well as the plat restrictions contained therein, are on file with the Department of Regulatory and Economic Resources.

### **Scope**

This plat is located in Commission District 8, which is represented by Commissioner Danielle Cohen Higgins.

#### **Delegation of Authority**

There are no delegation requirements with this item.

### **Fiscal Impact/Funding Source**

If this plat is approved, the fiscal impact to the County would be approximately \$1,950.00 annually for new roadway construction adjacent to the project. These costs would be covered by the Department of Transportation and Public Works' annual General Fund allocation.

- Available public water and sewer lines abut the proposed subdivision. All parcels are required to connect to public water and public sanitary sewers


#### **Developer's Obligation**

RESOLUTION APPROVING THE PLAT OF SIENA NORTH FILED BY OCS-HS LOT OPTION POOL 01, L.P., LOCATED IN THE SOUTHEAST 1/4 OF SECTION 11, TOWNSHIP 56 SOUTH, RANGE 39 EAST (BOUNDED ON THE NORTH APPROXIMATELY 95 FEET SOUTH OF SW 209 LANE, ON THE EAST BY SW 127 AVENUE, ON THE SOUTH BY SW 216 STREET, AND ON THE WEST APPROXIMATELY 135 FEET EAST OF SW 128 COURT)

WHEREAS, this Board desires to accomplish the purposes outlined in the accompanying memorandum, a copy of which is incorporated herein by reference; and

WHEREAS, OCS-HS Lot Option Pool 01, L.P., a Delaware limited partnership, has this day presented to this Board a plat of certain lands lying in Miami-Dade County, Florida, said plat to be known as "Siena North," the same being a subdivision of a portion of land lying and being in the Southeast 1/4 of Section 11, Township 56 South, Range 39 East, Miami-Dade County, Florida, and it appears that all requirements of law concerning said plat insofar as the authority of this Board is concerned have been complied with,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that said plat is hereby approved; that the dedication of the streets, alleys and other rights-of-way however designated or depicted on said plat is hereby accepted; that the Miami-Dade County Plat Restrictions as listed on said plat are approved and are to be enforced; that approval of the plat is not a waiver of any zoning regulations; and that the requirements of the zoning existing on this land at the time this resolution is approved shall be enforced whether or not the various parcels on this plat conform to those requirements.
