#### NW 7TH AVENUE CORRIDOR REDEVELOPMENT AGENCY REGULAR MEETING

#### **OFFICIAL MINUTES – Tuesday, April 3, 2024**

- I. Call to Order CRA Board Chairwoman Pierre called the meeting to order at 6:02 p.m.
- II. Roll Call and Introductions –

- III. Public Comment/ Reasonable Opportunity to be Heard Sammy Lamy stated he has a staff agency in the area and introduced himself to the group. Jean Cerenord stated he has a restaurant in the area and hopes to receive future assistance from the CRA for his business.
- IV. Approval of Agenda Nadeige Theresias-Joisil moved approval of the Agenda, with a second from Jeffy Mondesir. *Motion passed*.
- V. Approval of February 20, 2024, Minutes Gene Lomando moved approval of the Minutes, with a second from Jeffy Mondesir. *Motion passed*.
- VI. Presentations
  - A. Florida Dept of Transportation (FDOT), Sergies Duarte Mr. Duarte spoke about the Golden Glades Interchange project and the purpose of the project is to enhance regional mobility. Mr. Duarte stated the project will go until Fall 2031, and gave an overview of the traffic changes, lane closures, hours of construction, and referenced their website where constituents can sign up for project updates. Manny Espinal stated there will be new drainage installed and 32 new bridges installed, emergency access, access to the Golden Glades Intermodal system, camera instillation, and the other positive aspects of the project. Raj Ramaswamy elaborated on the one-way connection from 826 Eastbound to I-95 Northbound, which is a significant improvement that is already underway. After some questions from the board members, the FDOT team elaborated on language accessibility, job opportunities, lane closure hours, property acquisition, and lighting.
  - B. MHCP Colab Inc. Melissa Hege and Matthew Hege provided an overview of their company and team, and their previous experience working with municipalities and other CRA's. Their areas of expertise include redevelopment, zoning and land use, mobility/transit-oriented developments, and public engagement/ public relations.

Matthew Hege spoke about their previous public and private partnerships and how they have positively leveraged these relationships. Melissa also spoke about the various software programs which will be used to create story maps which will be useful to show possible business and development opportunities. After various questions from board members, Melissa elaborated on additional services beyond the scope of work and previous projects completed in other municipalities.

C. NANA Inc. – Leroy Jones gave background information on the organization and stated NANA's previous work in other municipalities. Mr. Jones discussed NANA's long-standing experience with Miami-Dade County and the specific role each staff member will play under the new agreement. One of those activities includes business outreach to make certain that the community is aware of the various grant programs offered by the CRA and NANA. Ms. Victoria Goss provided an overview of the work and renovations done to some of the businesses within the NW 7<sup>th</sup> Avenue CRA. After several questions from board members, Ms. Cao stated that the hope is that we can open the grants program in the Fall 2024.

#### VII. Items for Review and/or Action

- A. Resolution 01-2024: Resolution Awarding an Economic Development Coordinator Bid Waiver Contract to MHCP COLAB LLC to Provide Economic Development Services to the Agency in the Amount of \$181,880 for a One-Year Term with Four, One-Year Options – Gene Lomando moved to approve the resolution with a second from Jeffy Mondesir. Motion passed.
- B. Resolution 02-2024: Resolution Awarding a Grants Administration Contract to Neighbors and Neighbors, Inc. to Provide Grants Services to the Agency in the Amount of \$175,000 for a One-Year Term with Four, One-Year Options Nadeige Theresias- Joisil moved to approve the resolution with a second from Jeffy Mondesir. Motion passed.

#### VIII. New Business –

- A. Administrative Updates Ms. Cao stated the NW 7<sup>th</sup> Avenue CRA annual report has been published. Ms. Cao also stated that the expansion item was approved at the Board of County Commissioners meeting and staff is working on finding a company to conduct the finding of necessity (FON). Ms. Cao gave an update on them out posted ("boots-on-the-ground") position and will be conducting interviews shortly.
- IX. Adjournment There being no additional business, the meeting adjourned at 7:50 p.m.



# Defining Small Businesses

#### Sec. 2-8.1.1.1.1. - Small Business Enterprise Services Program.

"21.

Small Business Enterprise ("SBE" or "SBE-Services") means a business entity certified by SBD, providing services, which has a valid business tax receipt issued by Miami-Dade County at least one (1) year prior to certification, an actual place of business in Miami-Dade County, not a Virtual Office, and whose three-year average gross revenues does not exceed the following contracting participation levels:

(i)	(i) Tier 1 — \$0 to \$750,000;		
(ii)	<li>(ii) Tier 2 — \$750,000.01 to \$2,000,000;</li>		
(111)	Tier 3 — \$2,000,000.01 to \$5,000,000; or		
(iv)	Tier 4 — \$5,000,000.01 to \$8,000,000.		

No firm shall be certified as a SBE where the personal net worth of any of its owners is more than one million five hundred thousand dollars (\$1,500,000), exclusive of: (a) the value of the primary residence for which there is a homestead exemption; (b) the value of the business; and (c) funds invested in an individual retirement account ("IRA"), 401k, pension, or other official retirement account. The owner MUST provide information about the terms and restrictions of the account(s) to SBD and certify that the retirement account(s) is legitimate. Representations as to a business entity's average gross revenues, personal net worth of owners and payroll shall be subject to audit."

#### Sec. 2-8.1.1.1.2. - Small Business Enterprise Goods Program.

"22. Small Business Enterprise ("SBE" or "SBE-Goods") means a business entity certified by SBD, providing services, which has a valid business tax receipt issued by Miami-Dade County at least one (1) year prior to certification, an actual place of business in Miami-Dade County, not a Virtual Office, and whose three-year average gross revenues does not exceed the following contracting participation levels:

The term Small Business Enterprise shall also include a (x) manufacturer with one hundred (100) employees or less, or (y) wholesaler with fifty (50) employees or less, without regard to gross revenues. A wholesaler or manufacturer must comply with all other requirements of this section to be a certified SBE.

- To accomplish the Vision and the Mission of *STRIVE* 305, the goal is to support firms or vendors within TIER 1 & 2 of the SBE Goods and Services Program. These small businesses would be defined as any small business below \$2 million of gross receipts with ten or fewer employees.
- Small Business Data provided by Miami Foundation as of March 31, 2022, out of the 61,272 businesses registered approximately 52,079 or 85% fits the Tier 1 & 2 SBE category.

- (i)Tier 1 \$0 to \$750,000;
- (ii)Tier 2 \$750.000.01 to \$2.000.000:
- (iii)Tier 3 \$2,000,000.01 to \$5,000,000; or
- (iv)Tier 4 \$5,000,000.01 to \$8,000,000.





# Why are Community Redevelopment Areas created?

**Established under** Florida Statute (F.S.) **Chapter 163 Part III** to eradicate slum and blight through revitalization

### Slum and Blight is defined as:

- Area of declining health, safety, welfare
- Decline of businesses and residences
- Land use concerns related to parcels, assembly
- Roadway layout
- Areas prone to flooding
- Areas with contamination



#### To Preserve and Enhance the Tax Base

### **Objectives for preserving the tax** base

- Create clean and safe places
- Reduce crime
- Economic development
- Increase housing options
- Infrastructure and streetscape improvements
- Business retention and attraction
- Enhance parks and recreation

# What type of improvements can be funded?

- . Redevelopment efforts
- . Administrative costs
- . Funding and financing
- Redevelopment planning
- Property acquisition
- Loan repayment and debt
  expenses
- Relocation

# What else can be funded?

Only improvements and activities included in the redevelopment plan may be funded.

Improvements above and beyond what the County is already responsible for doing.

- Any investment with a return on the expenditure of public dollars
- Any visual improvements and enhancements
- Capital improvements that are not already included in the County's capital improvement plan budget

# What cannot be funded?

Marketing, promotion and special events.

Grants to entities that promote tourism and economic development or to provide social programs.

Adminstrative and operating expenses, projects and activities unrelated to the redevelopment plan.

- Unrelated government expenses
- Unrelated projects and programs
- Payment for CRA Board member service
- Any program or project that is not a physical improvement or financing for a physical improvement



Special events cannot be funded with CRA monies

### Special exceptions to funding

Innovative community policing subject to the approval by Board of County Commission.

Capital improvements that were removed from the County's CIP schedule 3+ years ago and part of the Redevelopment Plan.



### How is a CRA funded? How are the funds administered?

Tax increment financing is the increase in taxable value from the year the CRA is created.

The CRA Board members are appointed to govern the CRA and administer the Redevelopment Plan.


- Includes all taxable properties in the CRA
- Governed by an interlocal agreement
- Excludes payments by public entities, eg. Children's Trust, School Board and Water Management District

# When was the NW 7th Avenue CRA established?

NW 7th Avenue CRA established in June 2004, Board of County Commissioners (BCC) Resolution R-774-04

- Redevelopment Plan and Trust Fund established in 2004 for 30 years
- CRA will sunset in 2034
- Interlocal agreement with the County approved in 2012
- The expansion area was approved in June 2011.
- A new Redevelopment Plan was adopted in 2012.


