AN ORDINANCE OF THE VILLAGE COUNCIL OF MIAMI SHORES 3 VILLAGE, FLORIDA, AMENDING APPENDIX A, "ZONING," 4 ARTICLE II, "DEFINITIONS," SECTION 201, "TENSE AND 5 NUMBER; CERTAIN WORDS, TERMS DEFINED" TO UPDATE 6 DEFINITIONS; ARTICLE III, "DISTRICTS AND DISTRICT MAP," 7 SECTION 300(2) AND ARTICLE IV, "ESTABLISHMENT OF 8 REGULATIONS," SECTION 411, "SCHEDULE OF 9 REGULATIONS," TO INCLUDE THE COMMUNITY RESIDENTIAL 10 DISTRICT; AND CREATING DIVISION 25, "COMMUNITY 11 RESIDENTIAL DISTRICT" TO ESTABLISH REGULATIONS FOR 12 THE CR – COMMUNITY RESIDENTIAL DISTRICT; PROVIDING 13 FOR CONFLICTS; PROVIDING FOR SEVERABILITY; 14 PROVIDING FOR CODIFICATION; PROVIDING FOR AN 15 EFFECTIVE DATE.

IF ANY PERSON DECIDES TO APPEAL ANY DECISION MADE WITH RESPECT TO ANY MATTER CONSIDERED AT THE PUBLIC HEARING(S), THE PERSON WILL NEED A RECORD OF THE PROCEEDINGS AND FOR SUCH PURPOSES MAY NEED TO ENSURE THAT A VERBATIM RECORDING OF THE PROCEEDINGS IS MADE, WHICH RECORDS INCLUDE THE TESTIMONY AND EVIDENCE UPON WHICH THE APPEAL IS TO BE BASED.
