

I. Welcome/Introductions

Ms. Sandra Petithomme (SBD) called the Goods and Services Advisory Board meeting to order at 10:39 am, four (4) members were present.

II. Report - Jackson Health System (Juan Jaramillo/Romeka Brown)

- **a.** Mr. Juan Jaramillo summarized the report from the period of October 1st November 30, 2023.
- **b.** Mr. Holsendolph questioned whether the report was quarterly or yearly. He recommended a date timeframe be entered on future reports to notice progression. Mr. Jaramillo affirmed that it is a quarterly report and will take his suggestions into consideration.
- **c.** Ms. Gassant questioned if this report covered all Jackson facilities, to which Juan confirmed that it does. She also questioned what opportunities Small Business Enterprise (SBE) Set-Asides had to provide.
- **d.** Ms. Romeka Brown emphasized their due diligence in accessible spend. She explained that all bid waivers are reviewed, shared with the vendor partners, and signed off by Jackson's Small Business Program. She added that Jackson staff trained their department to seek SBE vendors, to ensure SBE's are a part of Jackson's procurement activities.

III. SBD Section Reports

a. Director Gary Hartfield

Mr. Harfield acknowledged Jackson's interconnectivity of their procurement department and the Small Business Program, which helps them understand their needs. Mr. Hartfield emphasized the importance of communicating to understand what is needed and what SBE firms could provide.

Mr. Gary T. Hartfield, Director of the Office of Small Business Development, addressed the board members regarding Senate Bill 742, emphasizing that the

legislation essentially mirrors actions taken eight months ago. He underscored a crucial aspect highlighted in the bill which emphasizes the language "local dollars or". Mr. Hartfield pointed out that Miami-Dade County had been extremely proactive in its Small Business Enterprise (SBE) program, which significantly contributes to the local economy by enabling small businesses to participate and ensuring their employees receive fair wages. He expressed concern that this legislation could impact the entire SBE program, workforce program, and wage program. He mentioned that the same version of the bill was discussed in the House of Representatives the previous Friday. Mr. Hartfield concluded that if the bill passes, by July 1, 2024, Miami-Dade County would no longer be able to enforce or implement its SBE, workforce, and wage programs on any future contracts, regardless of circumstances.

b. Business Outreach & Education - Lawanda Wright (SBD Section Chief)

- i. Ms. Lawanda Wright presented the report for the period of October 1, 2023, to November 30, 2023.
- ii. Ms. Wright informed the board that there were (4) four payment issues which equated to \$820,203. There was no prompt payment issues nor were there any contract issues. Contract opportunity emails were sent out to 3,403 firms during this period.

c. Certification - Jeanise Cummings-Labossiere (SBD Section Chief)

- i. Jeanise Cummings-Labossiere presented the report for the reporting period of October 1, 2023, to November 30, 2023.
- ii. She stated there were 1,378 SBE certified firms, a total of 40 approved new/recertified applications, (2) two firms graduated, and (1) one denied.
- iii. Mr. Holsendolph questioned if the average gross receipts increase the personal net worth. Director Hartfield informed Mr. Holsendolph that it did not increase the personal net worth and that it was going to committee. He noted there were several legislations, which were affecting the SBE program.

d. Utilization - Rossi Siewnarine (SBD Section Chief)

i. Mr. Siewnarine informed the board that the report covering the period from October 1st - November 30, 2023, encountered data issues and was unavailable. He assured the board members that it would be presented during the upcoming meeting.

IV. Discussion

i. Ms. Michou Jean advised the Advisory Board of the expectations of its members and the importance of attending scheduled meetings. She also expressed the administrative role of the Small Business Development (SBD) staff including the extent to which information was communicated via documentation, emails, and phone calls.

- ii. Board member Makeba Gassant suggested SBD staff send notification to all appointed board members in reference to legislative expectations to include attendance to establish quorum. She requested that an alternate board member conduct the subcommittee meetings if the chairperson was not in attendance. She recommended meeting once a month as opposed to twice a month.
- iii. Mr. Holsendolph questioned the process of board member participation as to why the physical presence of board members was so important. He also mentioned having an alternate to represent the absent board member could solve the issue.
- iv. Director Hartfield responded by stating that SBD advisory boards are governed by ordinances which would need to be amended with respect to physical attendance and alternates.

I. Welcome/Introductions

Ms. Michou Jean (SBD) called the Goods and Services Advisory Board meeting to order at 10:40 am, four (4) members were present.

II. Discussion

- i. Ms. Michou Jean briefed the Advisory Board on members expectations and stressed the importance of attending scheduled board meetings. She emphasized that it was the responsibility of Board Members to ensure their attendance for scheduled board meetings. Ms. Jean pointed out that maintaining attendance helps in achieving the quorum for the board meetings. She highlighted that SBD communicates with commissioners when a seat within a district becomes vacant. She specified this occurs that when an appointee had been absent from multiple meetings.
- ii. Mr. Holsendolph raised concerns about the county policy regarding appointed members who fail to attend board meetings. He stressed the impact of not meeting quorum impacts the boards' productivity. He suggested sending an attendance record to commissioners when appointed members have been absent from multiple meetings. Additionally, he recommended reducing the frequency of in-person board meetings and the number of board members to facilitate achieving quorum.
- iii. Ms. Makeba Gassant proposed that SBD staff take a more proactive approach in supporting the county's goals through the SBD program. Ms. Gassant emphasized that the board cannot fulfill the county's objectives administratively without a quorum.

II. Report - Jackson Health System (Amber Lawhorn/Juan Jaramillo)

- **a.** Ms. Amber Lawhorn summarized the report from the period of December 1, 2023 January 31, 2024. She highlighted that Jacksons' Small Business Enterprise (SBE) Team actively challenges bid waivers when the opportunity when feasible, assessing the scope of work, and product b purchases, and engaging with vendors. Ms. Lawhorn noted in some instances where bid waivers convert into competitive opportunities because of the reviews.
- **b.** Ms. Gassant expressed concern over the low accessible spend of just .69% in a significant budget, questioning areas of improvement was needed to achieve at least a one percent (1%) accessibility.
- **c.** Mr. Holsendolph inquired about the difference between a standardization bid waiver and a bid waiver, seeking clarification on of whether the bid waiver pertains to other SBE companies. is the standard product or price point of the product. Mr. Holsendolph advocated that Jackson provided opportunities to other SBE companies.
- **d.** Mr. Juan Jaramillo clarified that a standardization bid waiver was determined based on the product or a service standardization rather than pricing. He explained that a bid waiver could apply to either goods or services, emphasizing the involvement of Jackson's SBE Team in advisory committees and on professional organizations to promote awareness and local opportunities for Small Businesses.

III. SBD Section Reports

a. Director Gary Hartfield

Mr. Gary T. Hartfield, the Director of the Office of Small Business Development, briefed the board members on Senate Bill (SB) 742. He mentioned the bill had received unanimous approval from the Florida Senate. Mr. Hartfield indicated that the Senate had adopted the amended language proposed for SB 742. He informed the board members that the next step would involve the governor signing the bill into law. Mr. Hartfield emphasized that once the bill is signed, as of July 1, 2024, the County would no longer be able to enforce responsible wages and workforce measures as stipulated in the approved bills by the Florida House and Senate. Mr. Hartfield further explained that this bill would prohibit all Florida Counties from regulating contracts involving privately funded projects.

Additionally, Mr. Hartfield indicated that he had a discussion with the county attorney to gain insight into the potential impact on existing contracts with provisions for responsible wages, workforce measures, and Small Business Enterprise (SBE) participation. He noted that these contracts would likely remain in effect as initially agreed upon, since the legislation does not apply retroactively.

b. Business Outreach & Education - Carlos Ansuarez (SBD Section Chief)

- i. Mr. Carlos Ansuarez presented the report for the period of December 1, 2023 January 31, 2024.
- ii. Mr. Ansuarez informed the board that there were (8) eight payment issues which equated to \$631,048. There was no prompt payment issues but there were 3 contract issues. Contract opportunity emails were sent out to 2,623 firms during this period.

c. Certification - Jeanise Cummings-Labossiere (SBD Section Chief)

- i. Jeanise Cummings-Labossiere presented the report for the reporting period of December 1, 2023 January 31, 2024.
- ii. She stated there were 1,383 SBE certified firms, a total of 27 approved new/recertified applications, (0) no firms graduated, and (0) none denied.

d. Utilization - Rossi Siewnarine (SBD Section Chief)

- i. Mr. Rossi Siewnarine presented the report for the reporting period of December 1, 2023 – January 31, 2024. Mr. Siewnarine informed the board on t SBD's capability to identify contract associations, but it would require SBD to manually review each individual contract. He mentioned that SBD could provide a spreadsheet containing raw data of a two-month period.
- ii. Mr. Holsendolph questioned whether it was feasible to extract the dollar percentage data from payments and determining the allocation from pool contracts versus regular operations.
- iii. Ms. Gassant suggested that a printed version of the raw data be provided.



I. Welcome/Introductions

a. Chairman Darryl Holsendolph called the Goods and Services Advisory Board meeting to order at 10:46 a.m. Ms. Sandra Petithomme (SBD) conducted the roll call with five (4) advisory board members present.

II. SBD Section Reports

- i. Business Outreach & Education Lawanda Wright (SBD Section Chief) presented the report for the period of February 1, 2024 -March 31, 2024. Ms. Wright informed the board that there were nine (9) Payment Issues which equated to \$562,317 and there was no Prompt Payment Issues. She stated that there were five (5) non-dollar related Contract Issues. Ms. Wright mentioned to the board that SBD sponsored four (4) workshops/forums during this period.
 - Ms. Wright informed the board that Small Business Development (SBD) had an excellent turnout for Small Business Week (The first week of May). She stated that there were many non-certified firms in attendance daily and she expects an increase in new firms becoming certified with SBD.
- ii. Certification Jeanise Cummings (Section Chief) presented the report for the period of February 1, 2024 March 31, 2024. She informed the board that there were 1,388 certified firms, a total of forty-two (42) approved new/recertified applications, three (3) firms graduated, and none denied. Ms. Cummings explained the length of certification time for each of the three (3) graduating firms. She indicated that Personal Net Worth increase from \$1.5 to \$3.5 million, goes into effect May 17, 2024. She stated the information would be posted on SBD webpage and emails would be sent to graduated firms, encouraging them to re-apply for the program. She stated that the Gross Receipts adjustment increased from \$5 million to \$8 million.

iii. Utilization – Patrick Hines (SBD) presented the report for the period of February 1, 2024 - March 31, 2024. Mr. Hines informed the board of the total amount of contracts awarded (\$77,828,287) and contracts paid (\$71,451,125). Mr. Hines explained the demographics displayed on the chart for contracts awarded and paid.

Mr. Daryl Holsendolph suggested that this utilization report be sent to the Board of County Commissioners to highlight the need to address how business is conducted with Small Business Enterprise (SBE) firms.

Director Gary Hartfield informed the board that, if the chair wishes, , the data could be shared with the commissioners, including the chair's signature and an explanation of the intended actions or awareness. He explained that currently there was no mechanism or board resolution to present to the Board of County Commission (BCC). Mr. Hartfield expressed a desire for the report to include the actual dollar amount that could be allocated to SBE firms. He requested time from the board to collaborate with Mr. Hines to develop a chart that includes spend data, areas without measures , areas with measures , and the corresponding results.

III. Discussion

- a. Director Gary Hartfield stated that SBD had been tasked with reinventing the Small Business Program. He emphasized the need for certified firms and advisory board members to propose ways to enhance and elevate the program. Mr. Harfield highlighted the importance of understanding state regulations to improve our program. He informed the board that while the county could renew most contracts upon posting, they must adhere to contract terms, Mr. Hartfield clarified at the previous Goods and Services Board Meeting Minutes, noting that Senate Bill (SB)742 should be House Bill (HB) 705. He announced that, as of July 1, 2024, SBD would no longer be allowed to enforce the community workforce program, Employ Miami-Dade, or Residence First. He added that current projects with these requirements would continue to be monitored for compliance until the year 2030. He also mentioned that Responsible Wages would not be included in any Miami-Dade contracts starting 2026.,
- **b. Ms. Maria Molena** noted that the SBE program had flourished for 30 years. She pointed out that the program's benefits have not been adequately marketed. Ms. Molena emphasized that the SBE program allowed her to employ others, nurture professionals, and achieve economic success.
- **c. Mr. Daryl Holsendolph** suggested that SBD collaborate with universities to provide practical hands-on experience for business t school student interns. He explained that this approach would bring new ideas to the program and help guide its future direction. Mr. Hosendolph emphasized that it would also educate these future leaders about the economic benefits of the SBE program for local

government and develop future advocates for SBE. He suggested giving university interns challenges and allowing them to devise solutions.

d. Mr. Junior Silva proposed introducing legislation to extend contracts with SBE firms if no issues arise with the firm. He also recommended adherence to SBE guidelines for contracts and the establishment of time limits for evaluating projects.

IV. Report – Jackson Health System

- **a. Amber Lawhorn / Juan Jaramillo** summarized the report for the period of February 1, 2024 March 31, 2024. She highlighted the total spend (\$44,690,740), the inaccessible spend (\$43,161,533), and the accessible spend (\$1,529,207) for the period. She stated that the SBE Spend was \$139,472 and the percentage of SBE spend was 9.12%.
- **b. Mr. Daryl Holsendolph** requested JMH staff include quarter-to- quarter or period- to- progress in future reports. He specified that he wants to compare the spend from the accessible funds with the previous report.
- **c. Mr. Junior Silva** questioned whether the Bid Waiver amount was allocated to SBE's.
- d. **Mr. Juan Jaramillo** stated that staff communicated with vendors and consistently advocated for SBE firms, whether through logistical distribution or engaging in freight services. He highlighted emphasized that staff encourages all vendors with bid waivers to utilize local SBE firms.

NOTES

¹As a result of two landmark cases (Engineering Contractors Association v. Metropolitan Dade County and Hershell Gill Consulting Engineers, Inc. v. Miami-Dade County's three Small Business Enterprise (SBE) programs in Construction, A&E, and Goods and Services are race and gender neutral.

²The capturing of demographic data is based on voluntary information provided and or entered by prime and sub-contractors.

³Payments reported may be from contracts awarded outside the reporting period.

⁴It is important to note that the health of Goods and Services (G&S) contracts/awards should be identified by Contracts Paid instead of Contracts Awarded. This is due to the way G&S contracts are created in the County's Financial System. Prior to the County's new ERP system (April 2021) when pool contracts are created, the allocation amount is captured in one lumpsum and does not identify each individual award and to whom it was awarded. However, BMWS does capture who was paid and if they were an SBE or Non-SBE. We are working with the development team to see if G&S awards and payments can be better aligned and may change in the future.

⁵The exclusion of non-compete contract awards and payment data became effective July 2022. However, at the request of the Board, they would like to see everything. It was advised to the Board that it should be important to note that there will be contracts that will skew SBE data (ie: fuel, vehicle purchases, S8 vouchers, Headstart program, MDC employee health benefits, Microsoft software, etc.) 2021 Non-compete contracts represent a combined award total of approximately \$871,770,376. 2023 non-compete contracts represent a combined award total of approximately \$295,973,085.
