**I. Welcome/ Introductions**

- a. Chairman Darryl Holsendolph called the Goods and Services Advisory Board meeting to order at 10:45 a.m. Ms. Sandra Petithomme (SBD) conducted the roll call with five (5) advisory board members present.

**II. Report- Jackson Health System**

- a. Ms. Amber Lawhorne summarized the report for the period of April 1, 2024 – May 31, 2024. Ms. Lawhorne stated the total spend was \$68,559,035.00, the inaccessible spend was \$66,903,203.00 (97.6%), and the accessible spend was \$1,655,832.00 (2.4%) for the period. She informed the board that the spending with Small Business Enterprise (SBE) was \$111,511.00 of the accessible spend (6.73%). Ms. Lawhorne emphasized that based on the purchases and the analyses, in the accessible spend category, effort was put forth to maximize SBE spend for the period.
- b. Ms. Gasant questioned whether there was any outreach or collaboration that could be done between Jackson procurement and centralized Small Business Development (SBD) procurement to access vendors who may be able to provide other options such as goods services.
- c. Mr. Juan Jaramillo stated that they were being intentional in their approach, whether it was by collaborating with Miami-Dade County, JMH pool, or using bid waivers, to ensure that SBE’s could secure distribution deals with Original Equipment Manufacturers (OEM’s).

- d. Chairman Holsendolph stress the need to insist on increasing the the number of distributors, to ensure that SBE’s could distribute those products. He emphasized that the Original Equipment Manufacturers should seek out local firms interested in distributing their products.

**III. SBD Section Reports**

- a. **Business Outreach & Education – Carlos Ansuarez (Section Manager)** presented the report for the period of April 1, 2024 -May 31, 2024. Mr. Carlos Ansuarez informed the board that the information displayed in the report for the period was inaccurate and would be corrected in the next meeting.
- b. **Certification – Jeanise Cummings (Section Chief)** presented the report for the period of April 1, 2024 -May 31, 2024. She informed the board that there were 1,373 certified firms, a total of twenty-six (26) approved new recertified applications, one (1) firm graduated, and none denied.
- c. **Utilization – Patrick Hines (SBD)** presented the report for the period of April 1, 2024 -May 31, 2024. Mr. Patrick Hines informed the board of the total number of contracts awarded (\$26,876,792.00) and contracts paid (\$174,901,538.00). Mr. Hines explained that the demographics displayed are for contracts awarded and paid.

**IV. Discussion**

**a. House Bill (HB) 705 Presentation**

Mr. Gary T. Hartfield, Director of the Office of Small Business Development, briefed the board members on House Bill 705. He explained that the bill was signed into law on May 28, 2024, and became effective on July 1, 2024. Mr. Hartfield reported that HB 705 restricted Miami-Dade County’s ability to impose measures on construction projects and to conduct responsible wage practices. He stated the bill also affected workforce programs within Small Business Development (SBD), such as the Miami-Dade Community Workforce and Residents First programs, which had previously provided opportunities for local employees in Miami-Dade County.

Mr. Hartfield noted that Miami-Dade County was in collaboration with Small Business Development and the County Attorney's Office, working to determine how to proceed with construction contracts under the new legislation. He raised concerns about projects that were advertised before the July 1 enactment date and those that had already received responses from Miami-Dade County. He mentioned that Miami-

Dade County used various procurement methods, including capital construction projects over \$5 million, which were contracted and solicited by the appropriate department.

Additionally, Mr. Hartfield discussed the county's construction contract programs: the MCC 7040 plan, which is entirely set aside, and the MCC 7360 plan, which was an open competitive plan that includes Small Business Enterprises (SBEs). He clarified that the county attorney advised that projects that received bids before July 1 could continue to use the 7040 programs for procurement, allowing those projects to move forward and be awarded to the appropriate firms.

Mr. Hartfield emphasized that the HB 705 legislation would not impact Goods and Services, but he highlighted the importance of securing the support of the advisory board members, SBE firms, and all stakeholders for the changes presented to the board. He stressed the importance of actively engaging by contacting the Commissioners, and chamber representatives. Mr. Hartfield indicated that this collective effort was necessary to attract funding locally. Mr. Hartfield indicated that he would keep the board members informed as developments related to HB 705 progress.

Discussion ensued amongst the board members and Mr. Hartfield regarding the impact of (HB) 705 on small local businesses.

**V. Old Business**

- a. **Approval of meeting minutes for January 18<sup>th</sup>, March 21<sup>st</sup>, and May 16, 2024.** It was moved by Mr. Michael John Anthony Green to approve the Goods and Advisory Board Meeting minutes. This motion was seconded by Ms. Carmen Baker, and upon being put to a vote, the motion passed by a vote of 5-0.
